
STATE OF MINNESOTA DEPARTMENT OF ADMINISTRATION REORGANIZATION ORDER NO. 52

Pursuant to Minnesota Statutes 16.125, 16.13, and 16.135 the following reorganization is made.

All allotments, requisitions, encumbrances, and the allotted free balances for salaries including fringe benefits (21600:01-10), for supplies and expenses (21600:02-10), and all personal property assets are transferred from the Office of Liquor Control to the Department of Public Safety, Division of Liquor Control, as of January 1, 1975.

The administration of the appropriations made to the Liquor Control Agency are transferred to the Department of Public Safety.

It is not the intent of this order to change the status of any legal action pending by or against the Liquor Control Agency.

This order is effective January 1, 1975.
