

ORDINANCE NO. 173

AN ORDINANCE ANNEXING CERTAIN LANDS INTO THE CORPORATE LIMITS OF THE CITY OF WACONIA

WHEREAS, a majority of the property owners in number, have petitioned the Common Council of the City of Waconia for annexation of certain property, presently located in the Township of Waconia, County of Carver, State of Minnesota, said Petition having been submitted to the Common Council of the City of Waconia on the 2nd. day of January, 1975; and

WHEREAS, said Petition having been served on the Carver County Auditor, the Clerk of Waconia Township, and the Minnesota Municipal Commission, on the 2nd. day of January, 1975; and

WHEREAS, there having been no written objections submitted and the Township of Waconia having waived the sixty-day period in which objections could be made and having given its consent on February 4, 1975; and

WHEREAS, a hearing was held, in accordance with the provisions of Minnesota Statutes, Section 414.033, Subd, (5), on the 10th. day of March, 1975 with mailed notice having been sent to all property owners of record within the area to be annexed on February 6, 1975, in accordance with said Statute.

THE COMMON COUNCIL OF THE CITY OF WACONIA, CARVER COUNTY, MINNESOTA ORDAINS:

Section 1, Declaration. It is hereby determined that the territory described below abuts the present corporate limits of the City of Waconia; the said described lands platted and unplatted land that do not exceed 200 acres in area; that said lands are not now included in any other municipality; that said lands are conditioned as properly to be subjected to municipal government and that such annexation would be to the best interest of the City of Waconia and of the territory to be annexed.

Section 2. Territory Annexed. The corporate limits of the City of Waconia are hereby extended to encompass and embrace all of the territory described as follows, to-wit:

All of Government Lots 2, 3 and 4, Section 14, Township 116 North, Range 25 West, including those portions thereof platted as Harms LakeView Terrace, Harms Lake View Terrace First Addition, and Replat of Outlot "A" of Harms Lake View Terrace First Addition.

Also, all those parts of Government Lots 5 and 7, Section 14, Township 116 North, Range 25 West not now included within the corporate limits of the City of Waconia.

Section 3. Filing. The City Clerk is hereby directed to file certified copie s of this Ordinance with the Minnesota Municipal Commission, the Clerk of Waconia Township, the Carver County Auditor, and the Secretary of State in accordance with Minnesota Statutes, Section 414.033, Subd. (7).

Section 4. Effective Date of Annexation. Annexation shall be deemed final upon the filing of the certified copies of this Ordinance as directed in Section 3 hereof and publication as provided by law.
