

ORDINANCE NO. 148

AN ORDINANCE PROVIDING FOR ANNEXATION OF CERTAIN LAND ABUTTING THE CITY UPON PETITION OF ALL OF THE OWNERS OF SUCH LAND.

THE CITY COUNCIL OF DELANO, MINNESOTA, ORDAINS:

Section 1. That pursuant to a petition by all of the owners of certain property comprising less than two hundred (200) acres, legally described as follows:

Lot D of the Northeast Quarter of the Northwest Quarter of Section 13, Township 118, Range 25, Wright County, Minnesota, according to the recorded plat thereof, except the South 742.00 feet of said Lot and except the West 30.00 feet of said Lot. Subject to the right-of-way of U.S. Highway No. 12,

the City Council has unanimously determined that it is to the best interest of the city and to the best interest of the property to be annexed that it be annexed.

Section 2. The tract hereinbefore described is, by this Ordinance, declared to be annexed to the City of Delano, Minnesota.

Section 3. This Ordinance shall take effect upon its passage and publication, and upon the filing of a copy of this Ordinance with the Municipal Commission of the State of Minnesota, the County Auditor of Wright County, and the Secretary of State of the State of Minnesota.
