

ORDINANCE NO. 273 (NEW SERIES)

CITY OF BLUE EARTH

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF BLUE EARTH TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated April 23, 1975, requesting annexation of the territory hereinafter described was duly presented to the council; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 37 acres of unplatted land, no part of which is included within the limits of an incorporated city, and

WHEREAS, the petition was signed by all owners; and

WHEREAS, no objections to the annexation have been received from the town board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the East, West and North boundaries thereof;

Be it ordained by the City Council of the City of Blue Earth as follows:

Section 1. The city council hereby determines (1) that the annexation will be to the best interest of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is about to become urban in character; and (3) that none of said territory is now included within the limits of any city.

Section 2. Territory Annexed. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

That part of the South Half of the Northwest Quarter of Section Twenty (20) and the East Half of the Northeast Quarter of Section Nineteen (19) all in Township One Hundred Two (102) North, Range Twenty-seven (27) West of the Fifth Principal Meridian in Faribault County, Minnesota which lies North of the Westerly projection of the South Line of Royal Acres Addition to the City of Blue Earth, Minnesota according to the Plat thereof, on

file and of record in the office of the Register of Deeds, Faribault County, Minnesota excepting therefrom the following: (a) That portion of the East Half of the Northeast Quarter of said Section Nineteen (19) lying North of County State Aid Highway No. Six (6); (b) That portion lying within the platted area of Royal Acres Addition to the City of Blue Earth.

Section 3. Filing. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the Town Clerk, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
