Ordinance No. 87
AN ORDINANCE FOR THE PURPOSE OF PROMOTING HEALTH,
SAFETY, ORDER, CONVENIENCE
AND, GENERAL WELFARE, BY
REGULATING THE USE OF LAND,
THE LOCATION AND THE USE
OF EVILDINGS AND THE ARRANGEMENT OF BUILDINGS ON
LOTS, AND THE DENSITY OF
POPULATION IN THE VILLAGE
OF EDEN VALLEY, MINNESOTA

WHEREAS, Minnesota Statute 462,357 empowers the Village to enact a zoning ordinance and to provide for its administration, en-

forcement, and amendment, and WHEREAS, the Village Council deems it necessary for the purpose of promoting health, safety, order, convenience, prosperity and general welfare of the Village to enact such an ordinance, and

WHEREAS, the Village Council has adopted a Comprehensive Plan for the future physical development and improvement of the Village and deems it necessary to make regulations for different districts to carry out the purposes of the aforesaid Statute.

Now therefore the Village Council of Eden Valley, Minnesota ordains said ordinance, as published February 14, 1974 in the Eden Valley Journal, as amended and published March 21, 1974 in the Eden Valley Journal, and as amended and published hereafter:

ORDINANCE NO. 88
AN ORDINANCE FOR THE ESTABLISHMENT OF A UNIFORM
PROCEDURE FOR CHARGING
FOR UTILITY SERVICE BENE-

EE IF ORDAINED BY THE COM-MON COUNCIL OF THE VILLAGE OF EDEN VALLEY AS FOLLOWS: Subd. (1) Purpose

To codify and standardize existing practices regarding certain utility service hookups within the Village of Eden Valley, and to reimburse the Village for benefits conferred upon users of the municipal water and sewage system.

Subd. (2) Description of Service and Charge

Whenever any building, temporary or permanent, shall be connected to the municipal water system, the municipal sewer system, or both the municipal water and sewer systems, there shall be paid by the person who causes such

is desired. Payment shall be made in advance, together with the application. The Village Clerk shall keep and maintain a schedule of charges pursuant to this ordinance, and upon payment of the proper charge, shall issue a receipt showing that the charge has been paid. No connection shall be made as covered by this Ordinance until the application has been made to the Clerk and the requisite utility service benefit charge paid in full.

Subd. (5) Penalties

After the date this Ordinance becomes effective, any person or entity who causes a connection to be made as herein defined without previously applying for and paying the prescribed utility service benefit charge shall be guilty of a misdemeanor.

Effective Date: This Ordinance shall take effect upon publication following enactment by the Village Council.
