John E. Adams, upon being first duly sworn upon oath deposes and says:

1. That for more than ten years he has resided in the County of Hennepin, and State of Minnesota.

2. That the Manager Publishing Company is a corporation duly organized and existing under the laws of the State of Maine.

3. That said corporation has been organized for more than ten years past and as such, publishes a monthly periodical devoted to the interests of the grain, flour, feed, and coal trade of the northwest.

4. That the Manager Publishing Company operates and controls a printing establishment in connection with the publishing of the said Co-operative Manager and Farmer, and that the said paper so published, is printed in and distributed at Minneapolis, in the County of Hennepin and State of Minnesota, and is entered at the Post Office in Minneapolis, Minnesota, as second class matter, and has been so entered for the past ten years.

5. That the periodical so published by the Manager Publishing Company, is known as the Co-operative Manager and Farmer.

6. That the Co-operative Manager <sup>Publishing Company</sup> and ~~Farmer~~ have for the past ten years had offices in the Corn Exchange Building, and various other places in the City of Minneapolis, County of Hennepin, and State of Minnesota.

7. That the Manager Publishing Company is now located in the Corn Exchange Building, City of Minneapolis, County of Hennepin, and State of Minnesota, and at such place and

address contact<sup>d</sup> an office for the publishing, distributing, and sale of its periodical.

8. That all the employees of the said Manager Publishing Company, work out of its office located in the Corn Exchange Building, and there has its news gathering agencies, and its advertising managers, together with all other employees, aids and assistants, that are necessary to publish such a periodical.

9. That said Manager Publishing Company at its offices in the Corn Exchange Building, in the City of Minneapolis, County of Hennepin and State of Minnesota, enters into and makes contracts for all the business of this corporation, and there carries on all the necessary business of the corporation.

10. That J. F. Fleming is the duly authorized secretary of the Manager Publishing Company and that the said J. F. Fleming for the past ten years has carried on the business of this corporation at Minneapolis, Minnesota.

11. That in addition to the said J. F. Fleming there are other agents and officers of the Manager Publishing Company carrying on the business of the Manager Publishing Company whose true and correct names are at this time unknown to this deponent.

12. That these officers and agents are permanently in the State of Minnesota for the primary purpose of carrying on the business of the Manager Publishing Company in the State of Minnesota.

13. Deponent further states that to the best of his knowledge and belief the Manager Publishing Company, now doing business within the State of Minnesota did not file with the Secretary of State, a copy of its charter, or certificate, or Articles of Incorporation, duly authenticated by the proper authority.

14. That the Manager Publishing Company did not file a statement showing the proportion of Capital stock of said corporation, which is represented by its property located and business transacted in this State.

15. That deponent did not pay to the State of Minnesota the fee as required by law.

16. That said Manager Publishing Company has not complied with section No. 6206 and 6207 of the General Laws of Minnesota of 1913.
