

ORDINANCE NO. 75-1

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF APPLETON, MINNESOTA, TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain Petition dated May 13, 1975, requesting annexation of the territory hereinafter described was duly presented to the Council on the 13th day of May, 1975; and

WHEREAS, the quantity of land embraced within the area described in the Petition and bounded as described is 43.25 acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the Petition was signed by all owners; and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the Petition abuts upon the city limits at the South boundary thereof; The Council of the City of Appleton, Minnesota, ordains:

Section 1. The City Council hereby determines (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the City limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. Territory Annexed The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

All that part of the Southeast Quarter of the Northwest Quarter (SE $\frac{1}{4}$ --NW $\frac{1}{4}$), Section Twenty-three (23), and all that part of the

Southwest Quarter of the Northeast Quarter (SW $\frac{1}{4}$ --NE $\frac{1}{4}$), Section Twenty-three (23), all in Township One Hundred Twenty (120), Range Forty-three (43), lying North (N) and East (E) of the right-of-way line of the Chicago, Milwaukee, St. Paul and Pacific Railway Company; and all that part of the Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$ --SE $\frac{1}{4}$), lying North (N) and East (E) of the right-of-way of the Chicago, Milwaukee, St. Paul and Pacific Railway Company, except one and nine tenths (1.9) acres thereof described as being a three cornered piece of land lying North (N) of Highway No. 59 as laid out on June 12, 1945, and being a three cornered piece of land in the Southeast Corner (SE) of the triangle on the North (N) side of Highway No. 59, being a piece which measures Four Hundred Ten Feet (410') North (N) and South (S) and Four Hundred Three Feet (403') East (E) and West (W) in the Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$ --SE $\frac{1}{4}$), Section Twenty-three (23), Township One Hundred Twenty (120), Range Forty-three (43), Swift County, Minnesota.

Section 3. Filing The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. Effective Date This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
