1 ORDINANCE NO. 52 2 AN ORDINANCE ANNEXING PART OF THE  $NE_{\frac{1}{4}}^{\frac{1}{4}}NE_{\frac{1}{4}}^{\frac{1}{4}}$  AND  $NW_{\frac{1}{4}}^{\frac{1}{4}}NE_{\frac{1}{4}}^{\frac{1}{4}}$  OF SECTION 24, 3 TOWNSHIP 159 NORTH, RANGE 46 WEST 4 5 THE CITY COUNCIL OF KARLSTAD, MINNESOTA ORDAINS: 6 Section 1. That the following described unincorporated land 7 which is owned by the City of Karlstad and which abutts the comparate limits of the City of Karlstad, Minnesota, shall be annexed pursuant to M.S.A. 9 414.033, Sub. 1, to the City of Karlstad, Minnesota: 10 The West Twenty-seven (27) rods of the Northeast one-11 quarter of the Northeast one-quarter  $(NE_{\frac{1}{4}}^{\frac{1}{4}}NE_{\frac{1}{4}}^{\frac{1}{4}})$  of 12 Section Twenty-four (24), Township One Hundred Fiftynine (159) North, Range Forty-six (46) West; 13 All that part of the Northwest one-quarter of the North-14 east one-quarter (NWNE $\frac{1}{4}$ ) of Section Twenty-four (24), Township One Hundred Fifty-nine (159) North, Range 15 Forty-six (46) West, which lies East of the existing railroad right-of-way, according to the Government 16 Survey thereof. 17 Section 2.
