PARKING AND TRAFFIC RULES AND REGULATIONS  
NORMANDALE COMMUNITY COLLEGE, BLOOMINGTON, MINNESOTA

Section I - RULES AND REGULATIONS

The Minnesota Community College Board, pursuant to Minnesota Statute 169.966 and Minnesota Session Laws Chapter 966 Section 20 (1971) hereby adopts the following parking Traffic Rules and Regulations to be administered and enforced on the property of Normandale Community College.

1. Only those vehicles owned or operated by students or employees of Normandale Community College or to other persons having a purpose or function at the college may park on college property.
2. All persons parking vehicles on property owned, leased or occupied by the State Community College System will do so at their own risk. No responsibility will be assumed by the community college or the state because of loss of property, damage to vehicle while parked, damage which may be incurred through the process of impounding the vehicle or for any other damage or loss sustained while on the community college parking facility.
3. Parking is prohibited on college property between the hours of 1:00 a.m. to 6:00 a.m. with the following exceptions:
  - a. Vehicles that are owned or leased by the college. (College marked vehicles or state motor pool vehicles.)
  - b. Vehicles belonging to those persons covered by the above regulation (#1) who are in attendance at a college-sponsored activity which is not completed before 1:00 a.m.
    - 1) When approved activities are not completed until 1:00 a.m. or later, vehicles are to be removed from the college property within thirty minutes after the completion of the activity.
  - c. Vehicles belonging to college employees whose hours of employment require their presence at the college between the hours of 11:00 p.m. and 6:00 a.m.
  - d. Vehicles which have received a special permit for parking overnight, issued by the Dean of Students or his designee.
4. Parking is prohibited on college roadways, sidewalks, landscaped areas, safety zones, loading zones, within ten feet of intersections, adjacent to yellow curbs, and in areas where parking is expressly prohibited by signs. Exceptions to this regulation are as follows:
  - a. College-owned vehicles, when being used in the performance of work on college property.
  - b. Vehicles making delivery of goods to the college may park in the loading zones during required delivery time.
5. Special parking areas shall be designated for staff parking and shall require a staff parking permit which is available through the bookstore. The permit may be withheld for violations of the parking policy. No person shall park in a designated staff parking area without displaying a staff parking permit on the designated area of the vehicle.
6. Special parking areas shall be designated for handicapped students requiring easy access to campus facilities. Special parking permits will be issued by the Dean of Students without cost. No person shall park in the area designated for handicapped parking without displaying a special parking permit on the designated area of the vehicle.

7. Parking lanes are designated by painted lines. Parking on painted lines or parking in a position which occupies more than one parking lane is prohibited.
8. Designated parking for motorcycles and bicycles are clearly marked. These vehicles must park in the designated area.
9. Maximum speed of vehicles on college property shall be 20 miles per hour, and such lesser speeds as may be indicated by posted signs.

#### Section II - ENFORCEMENT

All authorized law enforcement officers shall see that all rules of this regulation are obeyed and shall arrest and prosecute offenders.

#### Section III - PENALTIES

1. Any person violating any provision of this regulation shall be guilty of a petty misdemeanor. Any fines paid as a result of a violation of this ordinance shall be paid to the Hennepin County Court in the same manner as fines received from the violation of City of Bloomington ordinances.
2. The President, or his designees may order any motor vehicle parked at the college in violation of these rules and regulations to be removed. The cost of such removal shall be borne by the owner or operator of the motor vehicle.
3. In any prosecution charging a violation of this ordinance, proof that the particular vehicle described in the complaint was parked in violation of this ordinance, together with proof that the defendant named in the complaint was at the time of such parking the registered owner of such vehicle, shall constitute a prima facie presumption that the registered owner of such vehicle was the person who parked or placed such vehicle at the point where such violation occurred.

#### Section IV - EFFECTIVE DATE

These rules and regulations shall be in full force and effect from and after their adoption according to law.

Enacted and ordained into a regulation this 12th day of August, 1975.

TO WHOM IT MAY CONCERN: Notice is hereby given that the Minnesota State Board for Community Colleges has directed that a hearing be held in the Commons Building at Normandale Community College, 9700 France Ave. South, Bloomington, Minnesota, at 10 o'clock am on August 8th 1975, pursuant to Minnesota Statute 169.766 and Minnesota Session Laws Chapter 966, Section 20 (1971), to consider the adoption of a regulation relating to the regulation of traffic and parking upon parking facilities and private roads and roadways situated on property owned, leased, occupied or operated by the Normandale Community College located in the City of Bloomington, Minnesota.

(1) Said newspapers are printed in the English language in newspaper format and in column and sheet form equivalent in printed space to at least 900 square inches. (2) Said newspapers are printed daily and are distributed at least five days each week. (3) Said newspapers have 25 per cent of their news columns devoted to news of local interest to the community which they purport to serve and do not wholly duplicate any other publication and are not made up entirely of patents, plate matter and advertisements. (4) Said newspapers are each circulated in and near the municipality which they purport to serve, have at least 500 copies regularly delivered to paying subscribers, have an average of at least 75 percent of their total circulation currently paid or no more than three months in arrears and have entry as second-class matter in their local post-office. (5) Said newspapers purport to serve the City of Minneapolis and vicinity in the County of Hennepin and have their known office of issue in the City of Minneapolis, in said county, established and open during its regular business hours for the gathering of news, sale of advertisements and sale of subscriptions and maintained by the managing officer of said newspapers or persons in his employ and subject to his direction and control during all such regular business hours and at which said newspapers are printed. (6) Said newspapers file a copy of each issue immediately with the State Historical Society. (7) Said newspapers have complied with all foregoing conditions for at least two years preceding the day or dates of publication mentioned below. (8) Said newspapers have filed with the Secretary of State of Minnesota prior to January 1, 1966, and each January 1 thereafter an affidavit in the form prescribed by the Secretary of State and signed by the managing officer of said newspapers and sworn to before a notary public stating that the newspapers are legal newspapers.
