
Enclosed is a copy of the Resolution, drawn up by our City Attorney, James R. Keating.

A RESOLUTION ADOPTING LAWS 1973
CHAPTER 123 (The Uniform Code of
Municipal Government) AS THE
GOVERNING LAW OF THE CITY OF WATERVILLE.

WHEREAS, pursuant to Minnesota Laws 1973 Ch. 123, Art. V. Section 5, Subd 2, the City of Waterville will cease to be governed by present governing law and will be governed by the Uniform Code of Municipal Government on July 1, 1975, unless an earlier change is provided for by resolution; and

WHEREAS, it is in the best interest of the citizens and City government that this transition occur as soon as possible,

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of Waterville that upon the filing of this resolution with the LeSueur County Auditor, the Minnesota State Auditor and the Minnesota Secretary of State, which filing is hereby directed to be made by the Clerk, the City of Waterville shall henceforth be governed pursuant to Minnesota Statutes 1971, Ch. 412 as amended by Laws 1973, Ch. 123.

BE IT FURTHER RESOLVED that the following election schedule is hereby adopted:

- a. The April 1974 election shall elect a mayor whose term shall run until April 1975 and two Councilmen whose terms shall run until November 1976.
- b. The April 1975 election shall elect a mayor whose term of office shall run until November 1976 and two Councilmen whose terms shall run until November 1978.
- c. The November 1976 election shall be in accordance with the Code above provided.
