

A RUSDEAFTON ADDPEND LANG 1073 CHAFTER 123 AS ARCHED BY LAWS 1974 CHAFTER 337 (The Uniform Code of Municipal Government) AS THE GOVERNMENT LAW OF THE CITY OF HOUT LAKES

WHIREAS, pursuant to Minnosota Laws 1973 Chapter 123, as amended by Lews 1974 Chapter 337, The City of Hoyt Lakes will coase to be governed by present governing law, and be governed by the Uniform Code of Municipal Government on July 1, 1975, unless an earlier change is provided for by resolution; and

WHIREAS, it is in the best interest of the citizens and city government of the City of Neyt Lakes that this transition occur as seen as possible.

NOW THEREFORM, DE IT RESOLVED by the City Council of the City of Mayt Lakes that the City of Mayt Lakes will scace to be governed by present governing law, and be governed by the Uniform Code of Municipal Government, and that upon the filing of this resolution with the St. Louis County Auditor, the Minnesota State Auditor and the Minnesota Secretary of State, which filing is hereby directed to be made by the clerk, the City of Mayt Lakes shall henceforth be governed pursuant to Minnesota Statutes, Chapter 412.
