

# ORDINANCE NO. 121

## Second Series

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF EAST GRAND FORKS, TO INCLUDE CERTAIN UNPLATTED LANDS IN SECTION 36, TOWNSHIP 152 NORTH, RANGE 50 WEST OF THE 5TH PRINCIPAL MERIDIAN, POLK COUNTY, MINNESOTA, NOT EXCEEDING 200 ACRES, WHICH TRACT CONTAINS 40.549 ACRES

The City Council of the City of East Grand Forks, Minnesota, do ordain:

Section 1. A petition has been filed with the City Council of the City of East Grand Forks, Minnesota, by the First National Bank in Grand Forks, as Trustee of that certain trust dated October 14, 1970, being all of the owners of the land hereinafter described, to have such land included within the City Limits of the City of East Grand Forks, Minnesota, that copies of said petition were filed with the Minnesota Municipal Commission, the Town Board of Grand Forks Township and the County Board of Polk County, Minnesota; that more than sixty (60) days have elapsed since such filings of said petition, and that no objections have been filed as is more fully shown by the records and files herein.

Section 2. That the tract of land being annexed is described as follows, to-wit:

A tract of land in Section 36, Township 152 North, Range 50 West of the 5th Principal Meridian which tract is comprised of a part of the southeast  $\frac{1}{4}$  of the northwest  $\frac{1}{4}$  and a part of the northeast  $\frac{1}{4}$  of the southwest  $\frac{1}{4}$  in said Section 36 and which tract is further described as follows, to-wit:

Commencing at a point on the north line of Outlot 46 of "Auditor's Plat of Outlots 17 thru 64, Section 36, Township 152 North, Range 50 West of the 5th Principal Meridian, City of East Grand Forks, County of Polk, State of Minnesota" where said north line of Outlot 46 intersects a line lying parallel to and 1920.00 feet distant easterly from the west line of the aforesaid Section 36, said point of intersection being the true point of beginning; thence proceeding easterly along the said north line of Outlot 46 to the north-south  $\frac{1}{4}$  Section line in the said Section 36; thence proceeding northerly, along the said north-south  $\frac{1}{4}$  Section line, to the northeast corner of the southeast  $\frac{1}{4}$  of the northwest  $\frac{1}{4}$  of the said Section 36; thence proceeding westerly along the north line of said southeast  $\frac{1}{4}$  of the northwest  $\frac{1}{4}$  to a line lying parallel to and 1920.00 feet distant easterly from the aforesaid west line of Section 36; thence proceeding southerly on said line lying parallel to the west line of Section 36, to the true point of beginning, said described tract comprised of 40.549 acres, 21.940 of which lie in the southeast  $\frac{1}{4}$  of the Northwest  $\frac{1}{4}$  and 18.609 of which lie in the northeast  $\frac{1}{4}$  of the southwest  $\frac{1}{4}$ , all in Section 36, Township 152 North, Range 50 West of the 5th Principal Meridian, County of Polk, State of Minnesota.

Section 3. That the quantity of said land herein described is 40.549 acres.

Section 4. That the City Council hereby determines:

1. That the quantity of land embraced within the foregoing description is less than 200 acres.

2. That the annexation will be to the best interests of the City of East Grand Forks, Minnesota, and of the territory affected.

3. That the territory and land described above abuts the City of East Grand Forks, Minnesota, is suitably conditioned for municipal government, and is urban in character.

4. That the petition for annexation was signed by all of the owners of the land and real estate hereinabove described.

Section 5. The corporate limits of the City of East Grand Forks, Minnesota, are hereby extended to include the property described in Section 2, and the same is hereby annexed to and included in the City of East Grand Forks, Minnesota, as effectually as if it had originally been a part thereof.

Section 6. The Clerk-Treasurer is hereby directed to file certified copies of this Ordinance with the State of Minnesota Municipal Commission, the County Auditor, the Town Clerk and the Secretary of State of Minnesota.

Section 7. This Ordinance takes effect upon its passage and publication, and the filing of the certified copies as directed in Section 6, and be given the number 121-Second Series.

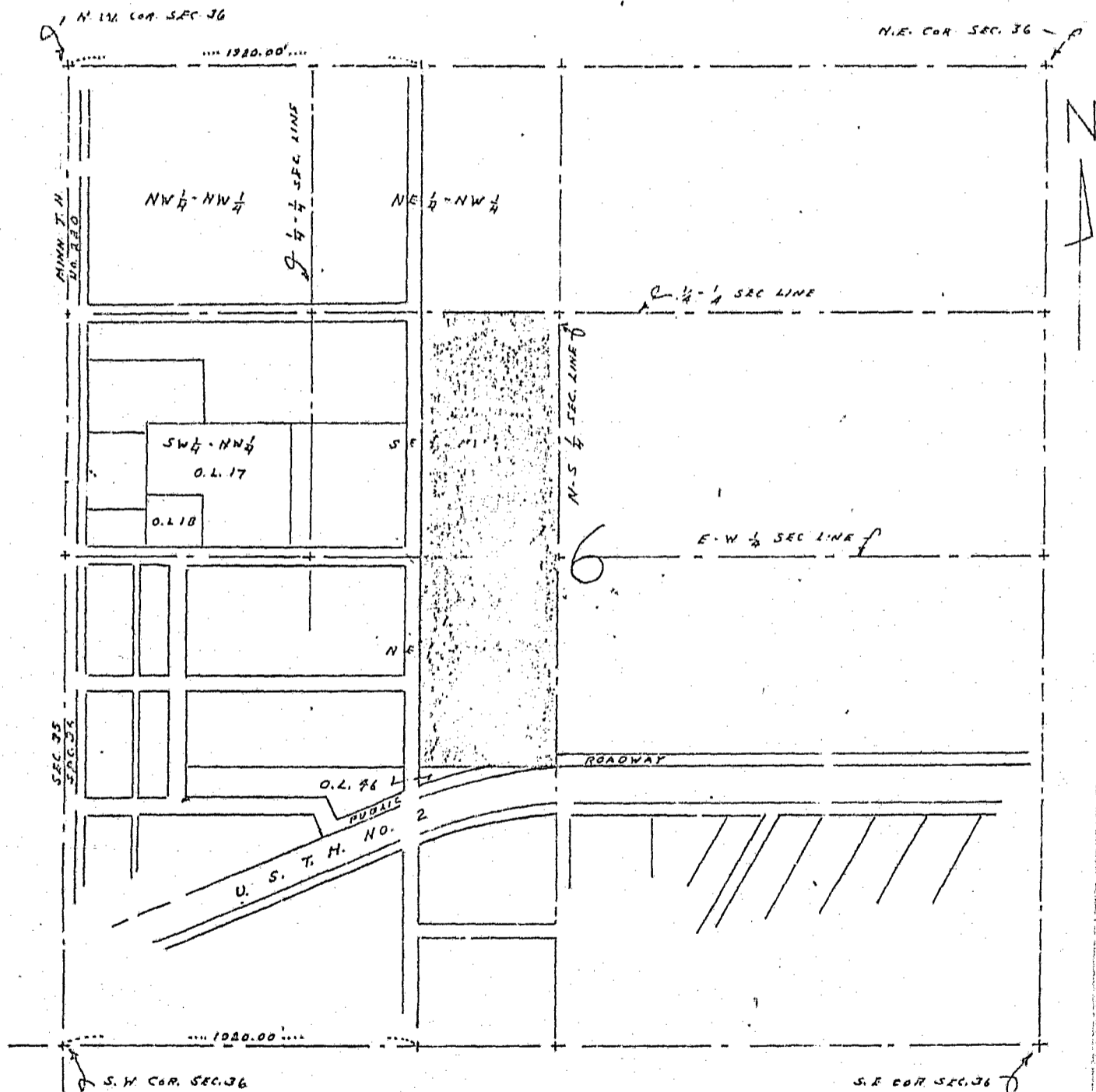
