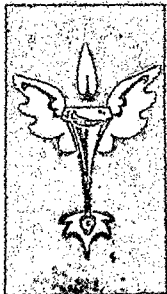

ORDINANCE NO. 327

BEING AN ORDINANCE RELATING TO THE ANNEXATION TO THE CITY OF LE SUEUR OF CERTAIN LANDS SITUATED IN RURAL OTTAWA TOWNSHIP, LE SUEUR COUNTY, MINNESOTA

The City of Le Sueur does ordain:


Section 1. That pursuant to the provisions of Minnesota Statutes annotated Section 414.033, the following described lands are hereby annexed by the City of Le Sueur and shall henceforth be included within and be a part of the corporate limits of the City of Le Sueur, Minnesota, to-wit:

The Southwest Quarter (SW $\frac{1}{4}$) of the Southeast Quarter (SE $\frac{1}{4}$) of Section Thirty-six (36), Township One Hundred Twelve (112) North, Range Twenty-six (26) West, Le Sueur County, Minnesota.


Section 2. All the Ordinances and portions of Ordinances inconsistent herewith are hereby repealed.


Section 3. This Ordinance shall be in force and take effect from and after its passage, publication and after filing copies hereof with the Minnesota Municipal Commission, the Le Sueur County Auditor, the Minnesota Secretary of State and the Town Board for Ottawa Township and after compliance with any and all other provisions of applicable law.
