AN ORDINANCE ANNEXING THE NORTHEAST QUARTER OF THE NORTHWEST QUARTER (NE $\frac{1}{4}$ OF NW $\frac{1}{4}$) SECTION 16, TOWNSHIP 30, RANGE 22, RAMSEY COUNTY, MINNESOTA ACCORDING TO THE UNITED STATES GOVERNMENT SURVEY THEREOF. SUBJECT TO CENTERVILLE ROAD.

and

ALL THAT PART OF THE EAST ONE-HALF OF THE SOUTHWEST QUARTER (E $\frac{1}{2}$ OF SW $\frac{1}{4}$) OF SECTION 16, TOWNSHIP 30, RANGE 22, RAMSEY COUNTY, MINNESOTA, LYING NORTH AND WEST OF THE RIGHT-OF-WAY OF THE SOO LINE RAILROAD COMPANY.

WHEREAS, the annexation of the hereinafter described land to the City of North Oaks has been initiated pursuant to Minnesota Statute 414.033, Subd. 3 and Subd. 5 and

WHEREAS, all the requirements of Minnesota Statute 414.033, Subd. 3 and Subd. 5 necessary to the annexation by Ordinance of the hereinafter described land to the City of North Oaks have been satisfied,

The City Council of North Oaks Ordains:

Section 1. The following described lands be annexed to the City of North Oaks:

The Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$ OF NW $\frac{1}{4}$) Section 16, Township 30, Range 22, Ramsey County, Minnesota, according to the United States Government Survey thereof. Subject to Centerville Road.

and

All that part of the East One-Half of the Southwest Quarter (E $\frac{1}{2}$ of SW $\frac{1}{4}$) of Section, 16, Township 30, Range 22, Ramsey County, Minnesota, lying North and West of the right-of-way of the Soo Line Railroad Company.

Section 2. Said annexation shall take effect upon filing a copy of the Ordinance with the Minnesota Municipal Commission, the City Clerk, the County Auditor and the Secretary of State.
