PETITION IN THE APPOINTMENT OF THE PATH
TERRITORY TO THE CITY OF EVELLETH,
ST. LOUIS COUNTY, MINN.

TO THE HON. CITY COUNCIL OF THE CITY OF EVELLETH ABOVE NAMED:

The undersigned respectfully show the following facts to your Honorable Body, this petition being submitted pursuant to the Statutes of the State of Minnesota in such case made and provided.

That the undersigned are now and at all times herein question have each of them been legal voters residing within the following described territory situated in the County and State above named, to wit:

Commencing at the Northeast (Ne) corner of Section Six (6), Township Fifty-seven (57) North, Range Seventeen (17) West, and thence Westerly along the North section line of said section to the Northwest corner of said section Six (6), said North Section line being approximately coincident with that part of the South boundary line of the said City of Eveleth where said Section Six (6) adjoins said City of Eveleth on the South;

And thence Southerly along the West Section line of said Section Six (6) to the Southwest corner of the Southwest Quarter of the Northwest Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$) of said Section Six (6);

And thence Westerly along the North line of the Northeast Quarter of the Southeast Quarter (NE $\frac{1}{4}$ SW $\frac{1}{4}$) of Section One (1), Township Fifty-seven (57) North, Range Eighteen (18) West, said line being the East (E) and West (W) Quarter line, to the Northwest corner of said Northeast Quarter of the Southeast Quarter (NE $\frac{1}{4}$ SW $\frac{1}{4}$).

Thence Northerly along the last line of the West half of the Northeast Quarter (W $\frac{1}{2}$ of NE $\frac{1}{4}$) of said Section One (1), being the East One-sixteenth (1/16) line of said Section One (1), to the Northeast corner of the Northwest Quarter of the Northeast Quarter (NW $\frac{1}{4}$ NE $\frac{1}{4}$) of said Section One (1). #2872

And thence Westerly along the North line of said Section One (1) to the Northwest corner of said Section One (1) and thence Westerly along the North Section line of Section Two (2) in said Township and Range to the Northwest corner of the Northeast Quarter of the Northeast Quarter (NE $\frac{1}{4}$ NE $\frac{1}{4}$) of said Section Two (2);

And thence Southerly along the West line of the East half of the Northeast Quarter of said Section Two (2), being the East One-sixteenth (1/16) line of said Section, to the Southwest corner of the Southeast Quarter of the Northeast Quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$) of said Section Two (2).

And thence Southeasterly along a straight line diagonally across the Northeast Quarter of the Southeast Quarter (NE $\frac{1}{4}$ SE $\frac{1}{4}$) of said Section Two (2) to the Southeast corner of said Northeast Quarter of Southeast Quarter (NE $\frac{1}{4}$ SE $\frac{1}{4}$) of said Section Two (2);

And thence Southeasterly along a straight line diagonally across the Southwest Quarter of the Southwest Quarter (SW $\frac{1}{4}$, SW $\frac{1}{4}$) of said Section One (1), Township Fifty-seven (57) North, Range Eighteen (18) West to the Southeast corner of said Southwest Quarter of the Southwest Quarter (SW $\frac{1}{4}$, SW $\frac{1}{4}$) of said Section One (1);

And thence Southeasterly along a straight line diagonally across the Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$ NW $\frac{1}{4}$) of Section Twelve (12) in said Township and Range to the Southeast corner of said Northeast Quarter of Northwest Quarter (NE $\frac{1}{4}$ NW $\frac{1}{4}$) of Section Twelve (12).

And thence Easterly along the South line of the North half of the Northeast Quarter (N $\frac{1}{4}$ of NE $\frac{1}{4}$) of said Section Twelve (12), being the North One-sixteenth (1/16) line of said Section Twelve (12), to the Southeast corner of the Northeast Quarter of the Northeast Quarter (NE $\frac{1}{4}$ NE $\frac{1}{4}$) of said Section Twelve (12);

And thence Easterly along the South line of the North half of the Northwest Quarter (N $\frac{1}{4}$ of NW $\frac{1}{4}$) of Section Seven (7), Township Fifty-seven (57), North, Range Seventeen (17) West to the Southeast

corner of the Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$ NW $\frac{1}{4}$) of said Section Seven (7);

And thence Easterly along the South line of the North half of the Northeast Quarter (N $\frac{1}{2}$ of NE $\frac{1}{4}$) of said Section Seven (7), being the North One-sixteenth (1/16) line of said Section, to the Southeast corner of the Northeast Quarter of the Northeast Quarter (NE $\frac{1}{4}$ NE $\frac{1}{4}$) of said Section;

And thence Northerly along the East Section line of said Section Seven (7) to the Northeast corner of said Section and thence Northerly along the East Section line of Section Six (6) in Township Fifty-seven (57) North, Range Seventeen (17) West, to the point of beginning, to-wit: the Northeast corner of said Section Six (6).

That no part of said territory is included in any existing incorporated city or village and that said territory is of a character proper for annexation and suitable for Municipal Government; that a portion of said territory is platted; that said territory adjoins the said City of Eveleth and that no part of said territory is more than one and one-half (1½) miles from the present limits of said City of Eveleth, which City is incorporated and exists as a Municipality in said County and State aforesaid.

That said territory embraces approximately One Thousand, Five Hundred and Forty (1,540) acres of land and has a resident population of not less than Seventy-five (75) persons; that in fact the number of actual residents therein is more than Six Hundred and Sixty-seven (667) persons, all as has been duly ascertained by a certain census taken and caused to be taken by and under the direction of your petitioners, between September 26th, 1922 and September 30th, 1922, both dates inclusive, pursuant to the said Statutes of Minnesota, as appears by the verification hereto, a copy of said census being heretofore filed in the office of the City Clerk of said City.

That your petitioners desire to have said territory annexed to the City of Eveleth, which is incorporated as a Municipality as aforesaid and to have said territory become a part thereof, and to be included in said City of Eveleth, and all pursuant to the laws of the State of Minnesota as aforesaid including Sections 1800-1804 of the General Statutes of Minnesota for 1913.

And the undersigned therefore respectfully petition your Honorable Body to call an election for the determination of said proposed annexation and to appoint a time and place when and where the Electors actually residing within said territory may vote for or against said proposed annexation and that all other necessary and proper proceedings be duly taken and had to effect said proposed annexation.

CENSUS OF TERRITORY PROPOSED

TO BE ANNEXED.

The census of the population actually residing within the territory hereinafter described, situate in St. Louis County, Minnesota, and containing One Thousand, Five Hundred and Forty (1,540) acres, said census being taken between September 26th, 1922 and September 30th, 1922, both dates inclusive by Anton Nemanick, Steve Ramponi, Frank Rozinka, John Rozinka and Max Volcansek.

Said territory is described as follows, being the territory proposed to be annexed to the City of Eveleth, in said County and State, to-wit:

Commencing at the Northeast (NE) corner of Section Six (6) Township Fifty-seven (57) North, Range Seventeen (17) West, and thence Westerly along the North section line of said section to the Northwest corner of said section Six (6), said North section line being approximately coincident with that part of the South boundary line of the said City of Eveleth where said Section Six (6) adjoins said City of Eveleth on the South;

And thence Southerly along the West Section line of said Section Six (6) to the Southwest corner of the Southwest Quarter of the Northwest Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$) of said Section Six (6);

And thence Southerly along the West line of the East half of the Northeast Quarter of said Section Two (2), being the East One-sixteenth (1/16) line of said Section, to the Southwest corner of the Southeast Quarter of the Northeast Quarter ($SE\frac{1}{2}$ $NE\frac{1}{4}$) of said Section Two (2).

And thence Southeasterly along a straight line diagonally across the Northeast Quarter of the Southeast Quarter ($NE\frac{1}{4}$ $SE\frac{1}{4}$) of said Section Two (2) to the Southeast corner of said Northeast Quarter of Southeast Quarter ($NE\frac{1}{2}$ $SE\frac{1}{4}$) of said Section Two (2);

(NE $\frac{1}{4}$ NW $\frac{1}{4}$) of said Section Seven (7);

And thence Easterly along the South line of the North half of the Northeast Quarter (NW $\frac{1}{4}$ of NE $\frac{1}{4}$) of said Section Seven (7), being the North One-sixteenth (1/16) line of said Section, to the Southeast corner of the Northeast Quarter of the Northeast Quarter (NE $\frac{1}{4}$ NE $\frac{1}{4}$) of said Section;

And thence Northerly along the East Section line of said Section Seven (7) to the Northeast corner of said Section and thence Northerly along the East Section line of Section Six (6) in Township Fifty-seven (57) North, Range Seventeen (17) West, to the point of beginning, to-wit: the Northeast corner of said Section Six (6).
