KNOW ALL MEN BY THESE PRESENTS, That I, WARREN SPANNAUS, Attorney General of the State of Minnesota, by virtue of the authority vested in me by statute, do hereby constitute and appoint

THEODORE J. COLLINS


of St. Paul, Minnesota, as Special Attorney for the purpose of providing legal services to the State of Minnesota, Department of the Attorney General with respect to investigations and legal proceedings in matters in which the Attorney General acts for the Hennepin County Attorney, and to serve at the pleasure of the Attorney General. This appointment shall be effective October 28, 1975, and is subject to the terms and conditions hereinafter set forth:

1. REPORTS. The Special Attorney shall submit a monthly report setting forth in detail his activities regarding this appointment.

2. COMPENSATION AND EXPENSES. As compensation for satisfactory performance of the duties herein described, the Special Attorney shall be compensated on a \$45.00 per hour basis. The Special Attorney shall be reimbursed for travel expenses in accordance with the rules and regulations promulgated by the State of Minnesota, Commissioner of Administration governing the travel of state employees and officers. All compensation and expenses shall be paid from funds appropriated to the Department of the Attorney General. (Reimbursement from Hennepin County will be sought.)


3. STATUS. The Special Attorney shall not be considered a state employee, shall not be eligible for the state's life insurance or basic health benefits coverage and shall not accrue vacation or sick leave or any benefits other than those expressly provided herein.







TERMINATION OF APPOINTMENT OF SPECIAL ATTORNEY


The appointment filed with the Secretary of State on
