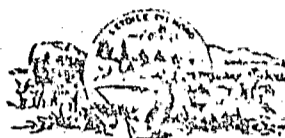

ORDINANCE ANNEXING THE CHARLES HAGAN PROPERTY ABUTTING  
THE CITY OF EAGLE LAKE

The City Council for the City of Eagle Lake Ordains:

That pursuant to M.S.A. 414.033 Subd. 5, the following  
described property located adjacent to and abutting the City  
of Eagle Lake is hereby annexed:

All that portion of the Southwest Quarter of the Southeast  
Quarter of Section 12, Township 108, Range 26, described as  
follows: Commencing at the Southeast corner of the South-  
west Quarter of the Southeast Quarter of said Section 12,  
West 280 feet thence North 438 feet to the Southwest  
boundary line of the right of way of the Chicago and  
Northwestern Railway. Then Southeasterly along said  
Southwestern line of said railway approximately 305 feet  
to the intersection of East line of said Southwest Quarter  
of Southeast Quarter of said Section 12 with Southwest  
Boundary line of said railway right of way. Then South  
along said quarter Section line approximately 325 feet to  
the point of beginning. The above tract contains 2.23 acres.
