AN ORDINANCE

CREATING & ESTABLISHING A SEWER DISTRICT

FOR THE

VILLAGE OF AMBOY, BLUE EARTH COUNTY

MINNESOTA

The Village Council of the Village of Amboy, Blue Earth Co., Minnesota,

DOES ORDAIN AS FOLLOWS:

THAT a Sewer District numbered One (1) is hereby created and established within and for the Village of Amboy, Blue Earth County, Minn. upon and including the territory in the said Village with the boundaries for said district as hereinafter specified:

SECTION I

The limits and boundaries of said Sewer District No. 1 shall be and are hereby established as follows:

Bounded by a line beginning at the south line of Main St. and the east line of Fourth Ave., thence south along the east line of Fourth Ave. to the south line extended of the alley south of South St., thence west along said line to North and South & section line of Sec. 23, thence north along said & section line to the south line extended of Block 3, Truve's Addition: thence west along said line to the south - west corner of Lot 11, Block 3, Truve's Addition, thence northerly along the west line of Lot 11, Block 3 and Lot 10, Block 2, Truve's Addition to the northwest corner of said Lot 10, thence easterly along the north line of Lots 9 and 10, Block 2, Truve's Addition to the S.E. corner of Lot 14 of Block 2, part of Amboy, thence northerly along the east line of Lot 14, to the N.E. corner of Lot 14, Block 2, part of Amboy, thence easterly along the north line of said Block 2 to the

extended west line of Lot 10, Block 1, Auditor's Plat, thence northerly along said line to the N. W. corner of Lot 10, Block 1, Auditor's Plat, thence westerly 165', thence southerly 99', thence westerly 66', thence southerly to the south line of Main St., thence westerly along the south line of Main St. to the west line of Radke St. (thence northerly along the west line of Radke St.) to the north line of Pearl St., thence easterly along the north line of Pearl St. to the southwest corner of Lot 8, Block 1, Radke's Addition; thence northerly along the west line of Lot 8, to the N.W. corner of Lot 8, Block 1, Radke's Addition, thence easterly along the north line of Block 1, Radke's Addition and the north line of Block 2, Randall's Addition and said line extended to the N.E. corner of Block 1, Randall's Addition, thence southerly along the east line of Blocks I and 4, Randall's Addition to a point 137' south of the south line of Pearl St., thence easterly to a point 52' north and 80' east of the northesst corner of Block 1, original town, thence southerly along the east line of Fourth Ave. to the south line of Main St. which is the point of beginning.
