An Ordinance Extending the Corporate Limits of the City of Willmar, a Municipal Corporation, of the State of Minnesota, to Include Certain Lands not Exceeding 200 Acres.

Whereas, A Petition has been filed with the governing body of the City of Willmar, a Municipal Corporation of the State of Minnesota, by the property owner having the sole interest therein, to have certain real property hereinafter described included within the limits of the City of Willmar, Minnesota, and

Whereas, It is proposed to annex by virtue hereof to said City of Willmar, Minnesota, and

Whereas, It is proposed to annex by virtue hereof to said City of Willmar said property, all of which property is in Kandiyohi County Minnesota, and

Whereas, The property to be annexed consists of 12.1 acres more or less, described as follows, to-wit:

That part of Government Lot 2 and of the Northwest Quarter of Northeast Quarter and of the South Half of Northeast Quarter of Section 23, Township 119, Range 35, described as follows, to-wit: Beginning at the Southwest corner of Pleasant View Addition, as of public record; thence on an assumed bearing of South 0 04' West along the West line of the Northeast Quarter of Said Section 23, a distance of 1522.96 feet to the Southwest corner of said Northeast Quarter; thence continuing on a bearing of South 0°04' West along the West line of Government Lot 2 of said Section 23, a distance of 35 feet, thence on a bearing of South 89°07' East, 319.36 feet; thence on a bearing of North 47°25' 15" East, 1445.92 feet; thence on a bearing of North 40°05' 07" West, 630.25 feet; thence on a bearing of North 0°04' East, 100 feet to the Southeast corner of said Pleasant View Addition; thence on a bearing of North 89°00' West, along the South line of said Pleasant View Addition, 960 feet to the point of beginning.

Now Therefore, The City Council of the City Willmar hereby determines, ordains and declares as follows:

Section 1. Best Interest of the City of Willmar and Area to be Annexed. That the annexation will be in the best interests of the City of Willmar, Minnesota, and of the property affected.

Section 2. Abuts on City Limits. That the property above described abuts on the City limits and is so conditioned as property to be subject to city government Section 3. Annexation. That the property is annexed to, and included within, the City of Willmar, Minnesota, as effectually as if it had been originally a part thereof.

Section 4. Zoning. The area above described shall be zoned R-2 Residence District.

Section 5. Effective Date. This ordinance shall be filed and shall be of full force and affect from and after the filing of the copy of this ordinance with the Minnesota Municipal Commission, the Willmar Town Clerk, and the Kandiyohi County Auditor, Secretary of State of the State of Minnesota, and from and after its passage and publication.
