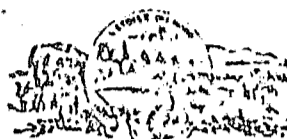

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF
THE CITY OF STAPLES AND INCORPORATING ADDITIONAL
TERRITORY THEREIN.

The City Council of the City of Staples does ordain
as follows:

Section I.

A Petition has been filed with the governing body of the
City of Staples, Minnesota, by Donald L. Kemp and Mildred Kemp,
the owners of the following described real estate for the purpose
of having such real estate included within the City of Staples,
Minnesota:

The North 100 feet of Block 11 of O'Connor's Addition to
the City of Staples according to the plat thereof on file
and of record in the office of the Register of Deeds in
and for Todd County, Minnesota, together with all abutting
roads and streets, as located in the Northwest Quarter of
the Northwest Quarter (NW $\frac{1}{4}$ NW $\frac{1}{4}$) of Section 1, Township 133,
Range 33 (Todd County, Minnesota).

Section II.

The above described real estate is platted and Donald L.
Kemp and Mildred Kemp are the sole owners of the property.

Section III.

Notice of the filing of the petition has been filed with the
Town Board of Staples Township, the Todd County Board of Commis-
sioners, the Minnesota Municipal Commission, and the City of
Staples at least 60 days prior to the first reading of this ordi-
nance, and no objections to the petition have been received.

Section IV.

All fees required to be paid by the petitioners have been
duly paid.

Section V.

The City Council hereby determines that the annexation
will be to the best interests of the City of Staples, Minnesota,
and of the territory affected; the territory described herein
abuts upon the City and is so conditioned as properly to be
subjected to City government.

Section VI.

Therefore, the City of Staples, Minnesota hereby ordains and declares that the property hereinbefore described be and the same are hereby annexed to, and included in, the City of Staples, Minnesota, as effectually as if it had originally been a part thereof.

Section VII.

This ordinance shall be final and shall take effect and be in force from and after filing a certified copy thereof with the Minnesota Municipal Commission, the Town Clerk of Staples Township, the Todd County Auditor, and the Minnesota Secretary of State.


