

ORDINANCE NO. 1975-2

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF APPLETON TO INCLUDE CERTAIN UNINCORPORATED TERRITORY OWNED BY THE CITY AND ABUTTING THEREON.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village, or borough; and

WHEREAS, this territory is owned by the City of Appleton, and abuts on lands already included within the corporate limits of the City and is deemed to be urban in character;

The City Council of Appleton ordains:

Section 1. Territory Annexed. The corporate limits of the City of Appleton, Minnesota, are hereby extended to include the unplatted territory described as follows, which territory now is and has heretofore been owned by the City of Appleton and abuts on territory already included within the City limits;

The North Half of the Southwest Quarter (N $\frac{1}{2}$ --SW $\frac{1}{4}$ ), Section Fifteen (15), Township One Hundred Twenty (120), Range Forty-three (43), except that part of the Northeast Quarter of the Southwest Quarter (NE $\frac{1}{4}$ --SW $\frac{1}{4}$ ), lying South (S) and East (E) of the Pomme De Terre River, Swift County, Minnesota.

Section 2. Filing. The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, and the Minnesota Municipal Commission.

Section 3. Effective Date of Annexation. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2.

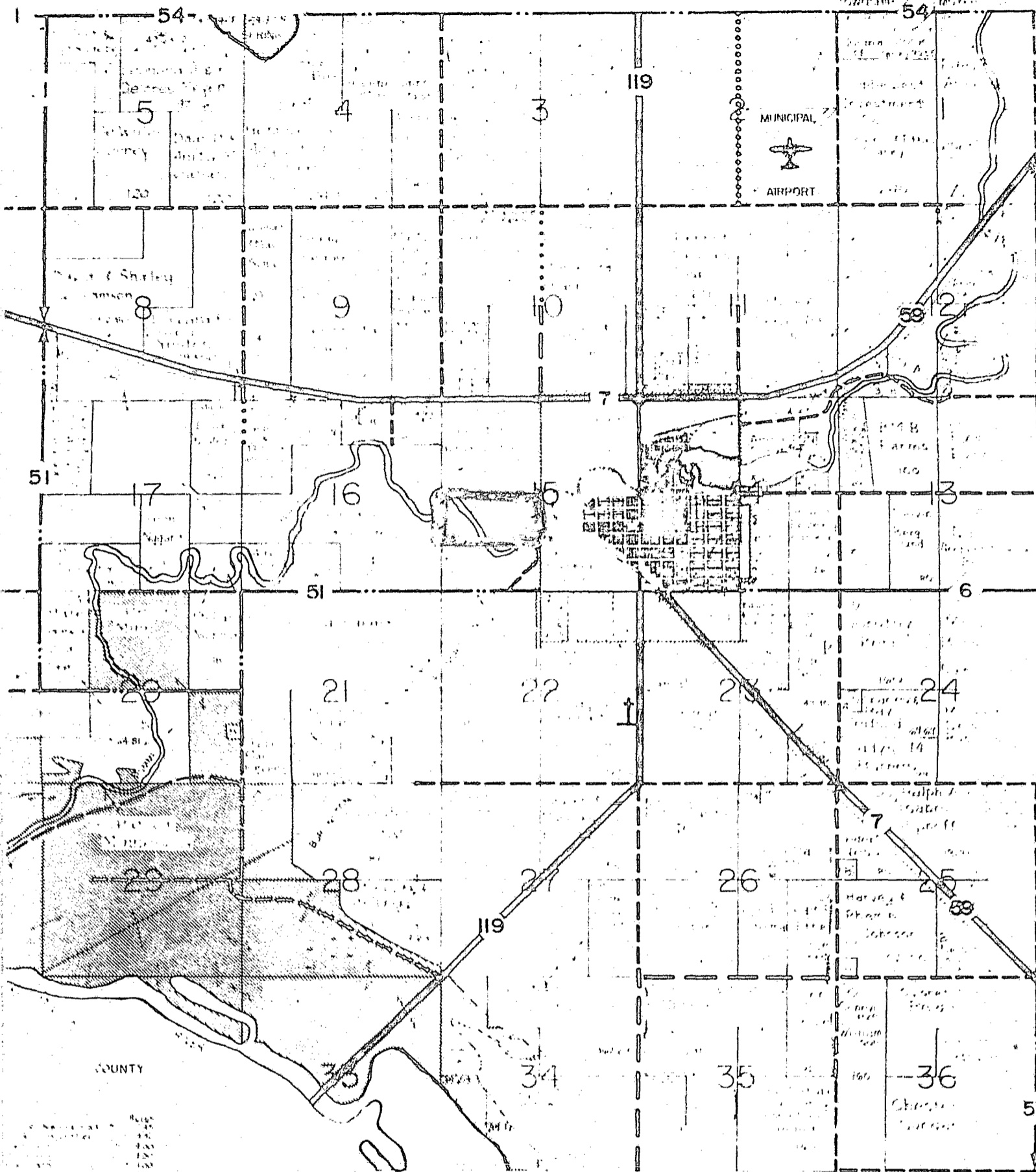
