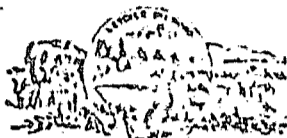



AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ARLINGTON TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ADJACENT UPON THE CITY LIMITS.

WHEREAS, a certain petition dated May 6th, 1975, requesting annexation of the territory hereinafter described was duly presented to the Council on the 6th day of May, 1975; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 40 acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by all owners; and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the South boundary thereof;

The Common Council of the City of Arlington, Minnesota, does ordain:

Section 1. The City Council hereby determines (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the city limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. Territory Annexed. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

The Northwest Quarter of the Northwest Quarter (NW $\frac{1}{4}$ of NW $\frac{1}{4}$) of Section Number Fifteen (15) in Township Number One Hundred Thirteen (113) North of Range Number Twenty-seven (27) West, Sibley County, Minnesota, also including abutting roads and rights of way, and containing 40 acres.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. Effective Date of Annexation. This Ordinance takes effect thirty days after its passage and publication and the filing of certified copies as directed in Section 3.
