

ORDINANCE NO. 140

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF EVELETH TO INCLUDE CERTAIN UNINCORPORATED LAND NOT EXCEEDING TWO MUNDRED ACRES IN AREA AND ABUTTING UPON THE CITY LIMITS.

Whereas, a potition of all of the property owners of the within described land requesting annexation of said land to the City of Eveleth has been received by the City Council and copies of said petition have been filed as required by law;

Whereas, 60 days have elapsed since the filing of said petition with the parties entitled by law to object thereto, and no such objection has been made; and

Whereas, said land is included in proceedings for annoxation which are pending before the Municipal Commission of the State of Minnesota, and said commission, by its order of April 29, 1975 has empowered the City of Eveleth to take action on paid potition; and

Whoreas, the Council of the City of Eveloth finds that said land is approximately 14.2 acros in area, abuts upon the municipal boundaries of the City of Eveleth, is unincorporated land, is properly subject to municipal government and that annexation of said land to the City of Eveleth would be in the best interests of said land and city; therefore

The City Council of the City of Eveleth, County of St. Louis, State of Minnesota, ordains that: The following described land situated in the town of Missabe Mountain, County of St. Louis, State of Minnesota is hereby annexed to and made a part of the City of Eveleth, County of St. Louis, State of Minnesota as effectually as if it had originally been a part thereof, to-wit:

The Southwesterly quarter (1/4) of the Southeasterly Quarter (1/4) of Section Twenty Nine (S29), Township Fifty Eight (T58), Range 17 (R17), lying Easterly of the Easterly right-of-way line of Minnesota Trunk highway 53, excepting that partion lying Easterly of a line drawn five hundred feet Westerly of and parallel to the Easterly boundary of said Southwesterly Quarter (1/4) of the Southeasterly Quarter (1/4) of Section Twenty Nine (S29).

This ordinance shall take effect upon filing of certified copies thereof with the Municipal Commission of the State of Minnesota, the town clerk of the Town of Missabe Mountain, the county auditor of the County of St. Louis, and the Secretary of State of the State of Minnesota.
