owners and residents of the following-described tract,
(containing approximately 5718 acres), to-wit:

Tract situated in the South Half of the Northwest
Quarter ($S\frac{1}{2}NW\frac{1}{4}$) of Section Thirty-four (34), Township
One Hundred Six (106), (Midway Township), Range Thirty-
Four (34), in Cottonwood County, Minnesota, described
as follows:

Commencing at the Southeast corner of said Northwest
Quarter ($NW\frac{1}{4}$) of Section Thirty-four (34), Township
One Hundred Six (106), Range Thirty-four (34), this
being the place of beginning; thence West along the
South boundary line of said Northwest Quarter ($NW\frac{1}{4}$),
a distance of 981 feet; thence at right angle North
parallel with the East boundary line of said Northwest
Quarter ($NW\frac{1}{4}$), a distance of 501.5 feet; thence at
right angle West, parallel with the South boundary
line of said Northwest Quarter ($NW\frac{1}{4}$), a distance of
339 feet; thence at right angle South, parallel with

AN ORDINANCE RELATING TO ANNEXATION.

The City Council of Mountain Lake, Minnesota, ordains:

Section 1. Annexed Territory

The following-described territory is hereby annexed to the City of Mountain Lake, County of Cottonwood, and State of Minnesota, to-wit:

Tract situated in the South Half of the Northwest Quarter (S $\frac{1}{2}$ NW $\frac{1}{4}$) of Section Thirty-four (34), Township One Hundred Six (106), (Midway Township), Range Thirty-Four (34), in Cottonwood County, Minnesota, described as follows:

Commencing at the Southeast corner of said Northwest Quarter (NW $\frac{1}{4}$) of Section Thirty-four (34), Township One Hundred Six (106), Range Thirty-four (34), this being the place of beginning; thence west along the South boundary line of said Northwest Quarter (NW $\frac{1}{4}$), a distance of 981 feet; thence at right angle North parallel with the East boundary line of said Northwest Quarter (NW $\frac{1}{4}$), a distance of 501.5 feet; thence at right angle West, parallel with the South boundary line of said Northwest Quarter (NW $\frac{1}{4}$), a distance of 339 feet; thence at right angle South, parallel with the East boundary line of said Northwest Quarter (NW $\frac{1}{4}$), a distance of 99.5 feet; thence at right angle East, parallel with the South boundary line of said Northwest Quarter (NW $\frac{1}{4}$), a distance of 18.5 feet; thence at right angle South, parallel with the East boundary line of said Northwest Quarter (NW $\frac{1}{4}$), a distance of 402 feet, more or less, to a point of intersection with the South boundary line of said Northwest Quarter (NW $\frac{1}{4}$); thence at right angle West along the South boundary line of said Northwest Quarter (NW $\frac{1}{4}$), a distance of 218.5 feet; thence at right angle North, parallel with the East boundary line of said Northwest Quarter, a distance of 501.5 feet; thence at right angle West, parallel with the South boundary line of said Northwest Quarter (NW $\frac{1}{4}$), to a point of intersection with the West boundary line of said Northwest Quarter (NW $\frac{1}{4}$); thence at right angle North along the West boundary line of said Northwest Quarter (NW $\frac{1}{4}$), to a point, which point is a distance of 1228.5 feet North of the Southwest corner of said Northwest Quarter; thence at right angle East parallel with the South boundary line of said Northwest Quarter (NW $\frac{1}{4}$) to a point of intersection with the East boundary line of said Northwest Quarter (NW $\frac{1}{4}$); thence at right angle South along the East boundary line of said Northwest Quarter (NW $\frac{1}{4}$), to the place of beginning.

(Containing approximately 57.18 acres; including abutting roads and right-of-way; and which tract abuts upon the City of Mountain Lake, Minnesota.


Section 2. Effective Date
