The City Council of Mountain Lake, Minnesota, ordains:

Section 1. Annexed Territory

The following-described territory is hereby annexed to the City of Mountain Lake, County of Cottonwood, and State of Minnesota, to-wit:

Tract, situated in the Southeast Quarter of section Thirty-two, (32), Township One-Hundred Six (106), (Midway Township), Range Thirty-four (34), in Cottonwood County, Minnesota, described as follows:


Commencing at the Northeast corner of said Southeast Quarter (SE $\frac{1}{4}$), this being the place of beginning; thence West along the North boundary line of said Southeast Quarter (SE $\frac{1}{4}$), a distance of Three-Hundred Thirty-Three (333) feet; thence South parallel with the East boundary line of said Southeast Quarter (SE $\frac{1}{4}$), a distance of 1917.9 feet; thence East parallel with the North boundary line of said Southeast Quarter (SE $\frac{1}{4}$), a distance of Three-Hundred Thirty-three feet (333), more or less to a point of intersection with the East boundary line of said Southeast Quarter (SE $\frac{1}{4}$); thence North along the East boundary line of said Southeast Quarter (SE $\frac{1}{4}$), to the place of beginning; excepting therefrom, the East Thirty-three (33) feet of said tract hereinbefore described; also, except the following: The North 217.8 feet of the South 1176.8 feet of the East 133 feet of said Southeast Quarter (SE $\frac{1}{4}$).

Section 2. Effective Date


This Ordinance becomes effective on the date of its passage.


