AN ORDINANCE RELATING TO ANNEXATION.

The City Council of Mountain Lake, Minnesota, ordains:

Section 1. Annexed Territory

The following-described territory is hereby annexed to the City of Mountain Lake, County of Cottonwood, and State of Minnesota, to-wit:

Tract, situated in the Northwest Quarter (NW $\frac{1}{4}$ ) of Section Thirty-Four (34), Township One Hundred Six (106), Midway Township, Range Thirty-Four (34), in Cottonwood County, Minnesota, described as follows:

Beginning at a point on the west line of said Section Thirty-Four (34), a distance of 1750.50 feet north of the Southwest corner of the Northwest Quarter (NW $\frac{1}{4}$ ) of said Section Thirty-Four (34); thence North along said West line a distance of 575.00 feet; thence South 89°32'40" East along a line parallel with the south line of said Quarter a distance of 723.00 feet; thence South along a line parallel with said West line a distance of 575.00 feet; thence North 89°32'40" West along a line parallel with the South line of said Quarter a distance of 723.0 feet to the point of beginning.

Also: Beginning at a point on the west line of said Section Thirty-Four (34), a distance of 2,325.50 feet North of the Southwest corner of the Northwest Quarter (NW $\frac{1}{4}$ ) of said Section Thirty-Four (34); thence continuing North along said West line of Section Thirty-Four (34), a distance of 326.75 feet to the Northwest corner of said Section Thirty-Four; thence South 89°32'20" East along the North line of said Section Thirty-Four, a distance of 723.00 feet; thence South along a line parallel with the West line of said Section Thirty-Four (34), a distance of 326.67 feet; thence North 89°32'40" West along a line parallel with the South line of said Northwest Quarter (NW $\frac{1}{4}$ ) of Section Thirty-Four (34), a distance of 723.00 feet, to the point of beginning.


Section 2. Effective Date.
