You Are Hereby Notified, that the undersigned Robert Jaques of the County of St. Louis and State of Minnesota on November 15th, 1921 and on behalf of Jane Barker, Widow of Elijah Barker, of Sultan in the State of Washington, and acting as Attorney in fact for said Jane Barker, has filed in the Office of the United States General Land Office at Cass Lake, Minnesota, his application to have surveyed and located under the Act of July 1, 1898 (30 Stat., 597-620), the land situated in Section Two (2), Township Fifty-nine (59), North Range Twenty-four (24), West of the Fourth Principal Meridian, Itasca County, Minnesota, more particularly described as follows:

"Parcel Number One."

An unsurveyed island in the Lake known as Wasson Lake, which said parcel lies North of Lot 8, of Section 2, Township 59, North of Range 24, West of the 4th P. M., comprising 1.38 acres and more exactly located as follows; beginning at the Government quarter corner on the South side of said Section 2, running thence North 0° 21' East 1257.5 feet along the quarter line between Lot 7 and Lot 8, to a point, near the shore of said lake, thence North 59° 36' East 727 feet to a point on the shore of said parcel number One.

"Parcel Number Two."

An unsurveyed island in the lake known as Wasson Lake, which said parcel lies North of Lot 8, of Section 2, Township 59, North of Range 24 West of the 4th P. M., comprising .91

acres and more exactly located as follows: beginning at the Government quarter corner on the South side of said Section 2, running thence North 0° , $21'$ East 1257.5 feet along the quarter line between lot 7 and lot 8 to a point near the shore of said lake, thence North 35° , $27'$ East 525 feet to a point on the shore of said parcel Number Two.

"Parcel Number Three."

An unsurveyed island in the lake known as Wasson Lake, which said parcel lies North of Lot 7, of Section 2, Township 59 North of Range 24 West of the 4th P. M., comprising 2.07 acres and more exactly located as follows; beginning at the Government quarter corner on the South side of said Section 2, running thence North 0° , $21'$ East 1257.5 feet along the quarter line between lot 7 and lot 8, of said section 2, to a point near the shore of said Lake, thence North 21° , $9'$ West 1064 feet to a point, thence North 43° , $9'$ West 320 feet to a point on the shore of said parcel Number Three.

You are further notified that said application of the undersigned, for the survey and location of the land above described, is now pending in the office of the Commissioner of the General Land Office of the United States at Washington D. C.; and you are hereby notified to file in said office, within thirty(30) days from the service of this notice upon you, any evidence or brief you may desire to file, tending to show cause, if any therebe, why the land hereinabove described should not be surveyed and located as aforesaid, and disposed of as public land of the United States.
