

ORDINANCE No. 57

ORDINANCE No. 57 of the Village of Bovey, Minnesota, extending the village boundaries of said village, and including within said village certain unplatted lands abutting upon said village, pursuant to the petition of the owners of said lands.

WHEREAS, On the 14th day of December, 1922, there was duly delivered to, and filed with the Clerk and Village Recorder of the Village of Bovey, Minnesota, the petition to the Village Council of said village, in writing, of the owners of the lands hereinafter described, praying said council to proceed by proper ordinance to extend the village boundaries of said village so as to include said lands within said village, which petition alleged the signers thereof to be the owners of said lands, that said lands were not within the limits of any other village, that they were all unplatted, and abutting upon said village of Bovey, Minnesota; and

WHEREAS, Said petition was thereafter, and on said December 14th, 1922, duly presented to and filed with said Village Council, at a duly called and held meeting of said council, all members thereof being present; and

WHEREAS, At said meeting of said Village Council, a hearing was duly had upon said petition, and thereupon said council became advised and informed as to the said petition and all the matters therein stated, to-wit: That said petitioners are the owners of said lands; that said lands are not within the corporate limits of any other village; that said lands are wholly unplatted; that all said lands are abutting upon the said village of Bovey, Minnesota, and are so conditioned as to be subject to village government; and

WHEREAS, Upon such hearing said council determined to grant the prayer of said petition and extend the village boundaries of said village so as to include within said village all of the said lands so described in said petition and hereinafter described; NOW THEREFORE,

THE VILLAGE COUNCIL OF THE VILLAGE OF BOVEY, MINNESOTA,  
DO ORDAIN AS FOLLOWS:

SECTION 1. That the village boundaries of the Village of Bovey, Minnesota, be, and the same hereby are, extended so as to include within said village the following described lands, situate, lying and being in the county of Itasca, state of Minnesota, to-wit:

The South-east quarter of the South-east quarter ( $SE\frac{1}{4}$  of  $SE\frac{1}{4}$ ) of section Twenty (20);

The West One-half ( $W\frac{1}{2}$ ) of Section Twenty-eight (28);

The East One-half of the North-east quarter ( $E\frac{1}{2}$  of  $NE\frac{1}{4}$ ) of Section Twenty-nine (29);

The North One-half of the South-east quarter ( $N\frac{1}{2}$  of  $SE\frac{1}{4}$ ) of Section Twenty-nine (29), except the south four hundred feet thereof; and

The North-east quarter of the South-west quarter ( $NE\frac{1}{4}$  of  $SW\frac{1}{4}$ ) of Section Twenty-nine (29), except the south four hundred feet thereof;

All in Township Fifty-six North of Range Twenty-four West (56 N.R. 24 W.) of the fourth Principal Meridian in Minnesota;

said boundaries of said village being extended as follows: Commencing on the north boundary line of said village at the point where the north and south quarter ( $\frac{1}{2}$ ) line of said section twenty-eight intersects said north line of said village, same being at the south quarter ( $\frac{1}{4}$ ) post of said section twenty-eight, Township 56 North of Range 24 West, Itasca Coun-

ty, Minnesota, and running thence North upon and along said north and south quarter ( $\frac{1}{4}$ ) line of said Section Twenty-eight (28) to the North quarter ( $\frac{1}{4}$ ) post of said section, on the section line between said section twenty-eight and section Twenty-one (21) in said Township; thence west upon and along the north section line of said section twenty-eight to the North-west corner of said section; thence North upon and along the East section line of Section Twenty (20) in said Township a distance of eighty rods to the south Sixteenth line of said section twenty; thence west upon and along said sixteenth line, a distance of eighty rods to the East sixteenth line of said section twenty; thence south upon and along said east sixteenth line of said section twenty to the south section line of said section; thence south upon and along the East sixteenth line of said section Twenty-nine (29) in said Township to the point where said sixteenth line intersects the east and west quarter line of said section twenty-nine; thence west upon and along said quarter ( $\frac{1}{4}$ ) line of said section twenty-nine (29), a distance of one hundred sixty rods to the west sixteenth line of said section; thence south upon and along said west sixteenth line of said section twenty-nine to a point four hundred feet north of the south sixteenth line of said section twenty-nine, there intersecting the north boundary line of said village at the North-west corner of said village.

SECTION 2. All of the lands above described are hereby included within the village of ~~the Village of~~ Bovey, Minnesota, and within the corporate limits of said village, and the village boundaries of said village are hereby extended so as to include said lands within said village, and within the incorporation of said village, subject to the jurisdiction and control of said village and its village government.

SECTION 3. This ordinance shall take effect and be in force upon due publication thereof and the filing of a certified copy thereof with the Secretary of State of the state of Minnesota, as required by law.
