

AN ORDINANCE RELATING TO ANNEXATION.

The City Council of Mountain Lake, Minnesota, ordains:

Section 1. Annexed Territory

The following-described territory is hereby annexed to the City of Mountain Lake, County of Cottonwood, and State of Minnesota, to-wit:

Lot Five (5) of Esau's Subdivision of part of the South Half of the Southeast Quarter (S $\frac{1}{2}$ SE $\frac{1}{4}$) of Section Twenty-eight 28, in Township One Hundred Six (106) North, Range Thirty-four (34) West of the 5th P.M., in Cottonwood County, Minnesota;

Except a tract of land in Lot Five (5) of Esau's Subdivision of Part of the Southeast Quarter of Section Twenty-Eight (28), Township One Hundred Six (106) North, Range Thirty-four (34), West of the Fifth Principal Meridian, Cottonwood County, Minnesota, bounded by the following lines: beginning at the Southeast corner of said Lot Five (5), said corner being a distance of 1551.00 feet West of the East line of said Section Twenty-eight (28); thence Northerly, along the East line of said Lot Five (5), a distance of 210.00 feet; thence Westerly along a line parallel with the South line of said Section Twenty-eight (28), a distance of 185.00 feet; thence Southerly, along a line parallel with the East line of said Lot Five (5), a distance of 210.00 feet to the South line of said Lot Five (5); thence Easterly along the South line of said Section Twenty-eight (28), a distance of 185.00 feet, to the point of beginning.

(Containing approximately 5 acres; area to be residential)

Section 2. Effective Date.

This Ordinance becomes effective on the date of its passage.
