

PETITION FOR INCORPORATION OF THE
VILLAGE OF ORCHARD LAKE.

To the Honorable County Board of Dakota County, Minnesota.

We, the undersigned voters residing within the Territory hereinafter described, hereby respectfully petition your honorable body to call an election, and appoint a time and place when and where the electors actually residing upon the said lands may vote for the determination of the proposed incorporation of the Village of "ORCHARD LAKE" in the Counties of Dakota and Scott, and State of Minnesota.

And your petitioners hereby respectfully state and allege:

First, that the territory sought to be incorporated is a district containing sections and parts of sections none of which are included within the territory of any incorporated Village or City, and are wholly within the Counties of Dakota and Scott and State of Minnesota.

Second, that they have caused a census of the resident population to be taken and that the resident population of the territory sought to be incorporated as such village is 255.

Third, that about one half part of said territory has been platted into lots and blocks, and that said plats have been duly and regularly certified according to the laws of the State of Minnesota, and filed in the office of the Register of Deeds in and for the Counties of Dakota and Scott, and State of Minnesota, wherein said lands lie, and that the other lands are adjacent thereto.

Fourth, that the boundaries of such territory, and the quantity of the land embraced therein is as follows,




