Ordinance No. 123, 2nd Series

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF EAST GRAND FORKS TO INCLUDE CERTAIN UNPLATTED LAND IN THE EAST ½ OF THE WEST ½ OF THE NORTHEAST ¼ OF SECTION 35, TOWNSHIP 152 NORTH, RANGE 50 WEST OF THE 5th PRINCIPAL MERIDIAN, NOT EXCEEDING 200 ACRES, WHICH TRACT CONTAINS 19.260 ACRES

The City Council of the City of East Grand Forks, Minnesota, do ordain:

Section 1. A petition has been filed with the City Council of the City of East Grand Forks, Minnesota, by American Federal Savings and Loan Association; Angeline Surprenant, a single woman; Arnold Surprenant, as Executor of the Estate of Ernest Surprenant, deceased; and Ernest J. Surprenant, deceased; and Walter J. Mikkelson and Darlene D. Mikkelson, husband and wife, being all of the owners of the land hereinafter described, to have such land included within the City limits of the City of East Grand Forks, Minnesota; that copies of said petition were filed with the Minnesota Municipal Commission, the Town Board of Grand Forks Township, and the County Board of Polk County, Minnesota; that more than 60 days have elapsed since such filings of said petition, and that no objections have been filed as is more fully shown by the records and files herein.

Section 2. That the tract of land being annexed is described as follows, to-wit:

A tract of land in the East ½ of the West ½ of the Northeast ¼ of Section 35, Township 152 North, Range 50 West of the 5th Principal Meridian, which tract is described as follows; to-wit:

Commencing at a point on the North-South ¼ Section line in Section 35, Township 152 North, Range 50 West of the 5th Principal Meridian, which point is 1320.00 feet north of the center of said Section 35, thence easterly at right angles to said ¼ Section line for a distance of 661.90 feet to the true point of beginning; thence continuing easterly at right angles to the aforesaid North-South ¼ Section line of said Section 35 for a distance of 184.21 feet; thence deflecting left 14°40'03" and proceeding northeasterly for a distance of 493.67 feet more or less to the North-South ¼ line in the Northeast ¼ of said Section 35; thence deflecting left and proceeding northerly along said ¼ line, a distance of 1186.14 feet more or less to the ¼ corner on the north line of the Northeast ¼ of said Section 35; thence deflecting left and proceeding westerly along said North line of said Northeast ¼ for a distance of 661.98 feet to the West line of the East ½ of the West ½ of the Northeast ¼ of said Section 35; thence deflecting left and proceeding southerly along said West line of the East ½ of the West ½ of the Northeast ¼ for a distance of 1314.15 feet to the true point of beginning; said tract comprised of 19.260 acres in the East ½ of the West ½ of the Northeast ¼ of Section 35, Township 152 North, Range 50 West of the 5th Principal Meridian, County of Polk, State of Minnesota.

Section 3. That the quantity of said land herein described is 19.260 acres.

Section 4. That the City Council hereby determines:

1. That the quantity of land embraced within the foregoing description is less than 200 acres.

2. That the annexation will be to the best interests of the City of East Grand Forks, Minnesota, and of the territory affected.

3. That the territory and land described as above abuts upon the City of East Grand Forks, Minnesota, is suitably conditioned for municipal government and is urban in character.

4. That the petition for annexation was signed by all of the owners of the land and real estate hereinabove described.

Section 5. The corporate limits of the City of East Grand Forks, Minnesota, are hereby extended to include the property described in Section 2, and the same is hereby annexed to and included in the City of East Grand Forks, Minnesota, as effectually as if it had originally been a part thereof.

Section 6. The City Clerk-Treasurer is hereby directed to file certified copies of this Ordinance with the State of Minnesota Municipal Commission, the County Auditor, the City Clerk-Treasurer, and the Secretary of State of the State of Minnesota.

Section 7. This ordinance takes effect upon its passage and publication, and the filing of the certified copies as directed in Section 6, and be given the number 123-Second Series.

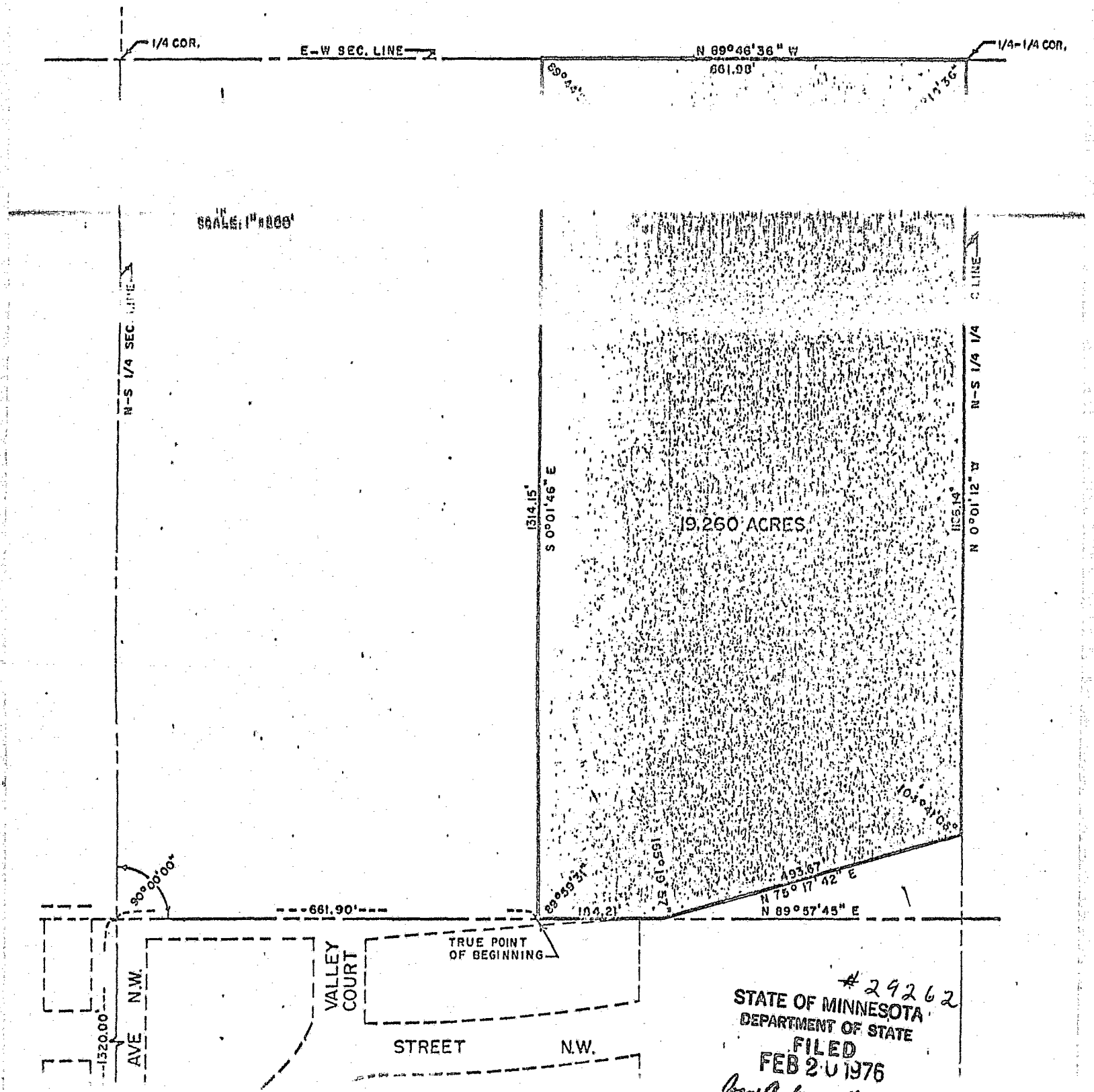
