FEES AND CHARGES ORDER NO. 19
AMENDING FEES AND CHARGES ORDER NO. 18

Effective April 9, 1976

Pursuant to authority vested in me by law, I, Robert L. Herbst, Commissioner of Natural Resources, do hereby establish the following fees and charges for State Park Facilities and republish herein the Fort Snelling Chapel Rental Fee Schedule established by the Commissioner of Administration pursuant to Laws of Minnesota 1974, Chapter 355, Sec. 44, Effective July 31, 1974. All previous orders establishing fees and charges are hereby rescinded and superceded by this order.

TOURIST CAMPS

\$3.00 per day per camp site. One picnic table and campfire base per site.
.50 per day per site (where available) electric services.

BOATS

ROW BOATS AND CANOES

\$2.00 first two hours
.50 each additional hour
Deposit Required
5.00 maximum daily charge

Exception: William O'Brien, Interstate and St. Croix - private concessions subject to annual negotiations.

Seasonal Boat Launching and Dockage Permit - \$15.00 per boat.

ORGANIZED YOUTH GROUP CAMP

CLASS I CAMP - Long Term (14 days or more)

\$20.00 per day (not to exceed 4 days) for pre-camp and post-camp period.

.75 per person per day during camping period or minimum daily charge based on rated capacity of the individual camp.

CLASS II CAMP - Short Term (less than 14 days) Minimum Rental - 2 days

\$30.00 per day or the charge per camper, whichever is greater.

1.00 per camper per day for the minimum rated capacity for camps, and the minimum rental period shall be two nights.

CLASS III PIONEER CAMP

\$.25 per camper per night (staff included).
3.00 minimum per group, per night.

Adult groups will be accommodated after all youth reservations are made at a fee of \$.50 per camper per night with a minimum of \$10.00 per group, per night.

SERVICE CHARGES FOR GROUP CAMPS

\$10.00 per hour for trucking service.

FORFEITURE CLAUSE

The Permittee agrees to forfeit twenty-five (25%) percent of the rental fee for short term use and twenty-five (25%) percent of the estimated long term use if the reservation is cancelled within the ten days prior to occupancy.

DAY USE OF GROUP CAMP DINING HALLS (10:00 a.m. to 10:00 p.m.)

A dining hall with refrigeration, electricity and cooking facilities \$25.00 per day.
