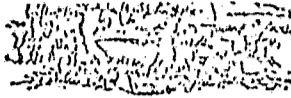

An Ordinance extending the Corporate Limits of the City of Franklin, of the State of Minnesota.

WHEREAS, A Petition has been filed with the governing body of the City of Franklin, by the sole owner having an interest therein to have certain real property hereinafter described, included within the City of Franklin Renville County, Minnesota and,

WHEREAS, it is proposed to annex by virtue hereof to the City of Franklin said property all of which said property is in Renville County, Minnesota, and;

WHEREAS, THE said property to be annexed is described as follows:

Beginning at the NE corner of the Northeast Quarter (NE $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$) of Section Twelve (12), Township One Hundred Twelve North (112N), Range Thirty Four (34) thence Westerly along said quarter section line a distance of 801 feet to present city limits of the City of Franklin, thence southerly a distance of 311 feet, thence easterly a distance of 801 feet, thence north a distance of 311 feet to point of beginning, containing 5.73 acres more or less

NOW THEREFORE THE City Council of the City of Franklin, hereby determines ordain and declares as follows:

1. That the annexation will be in the best interest of the City of Franklin and the land affected.
2. That the property abuts on the present city limits and the property is hereby annexed to and included within the City as if it was originally a part thereof.
