ORDINANCE NO. 34

AN ORDINANCE ANNEXING CERTAIN LANDS

TO THE CITY OF OKLEE

The City Council of the City of Oklee do hereby  
ordain as follows:

Section 1.

WHEREAS, All of the owners of the following described  
premises situated in the County of Red Lake and State of  
Minnesota, to-wit:

A parcel of land which is part of the SE $\frac{1}{4}$  of the  
NE $\frac{1}{4}$  and part of the E $\frac{1}{2}$  of the SE $\frac{1}{4}$  of Section 2,  
T. 150 N., R. 41 W. bounded as follows:

Beginning at the Southeast corner of the said NE $\frac{1}{4}$   
of Section 2; thence North along the East line of  
said Section 2 a distance of 570 feet; thence West  
at a right angle to said East line a distance of  
249.5 feet; thence South a distance of 762.93 feet;  
thence West a distance of 250 feet; thence South a  
distance of 900 feet; thence East a distance of 190  
feet; thence South a distance of 1548.52 feet to the  
South line of Section 2; thence East along said  
South line a distance of 309.5 feet more or less to  
the Southeast corner of said Section 2; thence North  
along said East line a distance of 2646.6 feet more  
or less to the point of beginning; containing 25.7  
acres more or less.

have petitioned the City Council to have such land included  
within the municipality and have filed copies of said petition  
with the Municipal Commission of the State of Minnesota, with  
the Town Board of Lambert Township and with the County Board  
of the County of Red Lake, State of Minnesota, and

WHEREAS, the above described property abuts upon the  
boundaries of the City of Oklee, and

WHEREAS, no objections to the proposed annexation have  
been submitted,

NOW, THEREFORE, It is hereby determined that the Annexation of said premises will be to the best interest of the City of Oklee and of the territory affected and the above described premises are hereby declared annexed to the City of Oklee.

Section 2.

This ordinance shall be in full force and effect from and after its passage, approval, publication and filing with the Municipal Commission, the Town Clerk, The Red Lake County Auditor and the Secretary of State of the State of Minnesota.
