OF VILLAGE.

To the Board of County Commissioners, Chisago County, Minnesota.

We, the undersigned, residents of the territory hereinafter described, hereby petition your honorable body asking that an election be called for the determination of the incorporation of the property or lands hereinafter described, as a Village, under and by virtue of Sections 1204 to 1209 incl., of the General Statutes of Minnesota for 1913 and the laws amendatory or supplemental thereto, and as grounds for said petition set forth the following facts:

That the lands or territory included in the proposed incorporated village consist of the following described tracts situated, lying and being in the County of Chisago and State of Minnesota, to-wit: The North One-half  $(N_2^1)$  of Section Thirty-two (32) and the South One-half  $(S_2^{\perp})$  of Section Twenty-nine (29), all in Township Thirty-four (34), Range Twenty-one (21), the said tracts of land or the territory proposed to be incorporated being bounded as follows: On the South by the East and West half section line of Section Thirty-two (32), on the West by that portion of the West section line of Section Thirty-two (32) lying North of the East and West half section line of said section and by that portion of the West section line of Section Twenty-nine (29) lying South of the East and West half section line of said section, on the North by the East and West half section line of Section Twenty-nine (29), on the East by that portion of the East section line of Section Twenty-nine (29) lying Bouth of the East and West half section line of said Section and by that portion of the East section line of Section Thirty-two (32) lying North of the East and West half section line of said section,

That said tracts of land contain Six Hundred and forty (640) acres, a portion of which has been platted into lots and blocks, That a census of the population of the above described tracts of land was taken on the 5th day of March, 1923 and that the population of said territory or lands on that date was One Hundred and twenty-seven (127).


