ORDINANCE NO. 165

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF GAYLORD TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated October 14, 1975, requesting annexation of the territory hereinafter described was duly presented to the city clerk on the 15th day of October, 1975; and

WHEREAS, the land described in the petition is not included within the limits of an incorporated city; and

WHEREAS, all of said land was owned by one person, who signed said petition; and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits:

THE COUNCIL OF THE CITY OF GAYLORD, MINNESOTA, ORDAINS:

Section 1. The city council hereby determines (1) that the annexation will be to the best interests of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

Lot Nine (9) in East Ridge Terrace, being a subdivision of part of Govt. Lot One (1) in Section Thirty-three (33), Township One Hundred Thirteen (113) Range Twenty-eight (28), including that portion of the road which abuts said lot on the north.

Section 3. Filing. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
