AN ORDINANCE AMENDING AN ORDINANCE OF THE CITY OF GREEN LAKE, MINNESOTA, CONCERNING TERRITORY TO BE ANNEXED TO SAID CITY.

WHEREAS, a certain petition dated October 15th, 1975, requesting annexation of the territory hereinafter described was duly presented to the Council of the City of Green Lake, Minnesota, on the 15th day of October, 1975; and

WHEREAS, the quantity of land embraced within the area described in the petition and hereinafter described is 3.52 acres of unplatted land, no part of which is included within the limits of an incorporated city; and

WHEREAS, the petition was signed by the sole owner of said land; and

WHEREAS, no objections to the annexation have been received from the town board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits on the west and north boundaries thereof;

The Council of the City of Green Lake, Minnesota, ordains:

Section 1. The City Council hereby determines (1) that the annexation will be in the best interests of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city.

Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

The west 369.3 feet of the South 416.50 feet of the Northwest quarter (NW 1/4) of Section Eighteen (18), Township Two Hundred Fourteen (114) North, Range Twenty-six (26) West, including abutting roads and rights of way, and containing 3.52 acres of land, Sibley County, Minnesota.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the Secretary of State, the Town Clerk and the County Auditor.

Section 4. Effective Date. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.

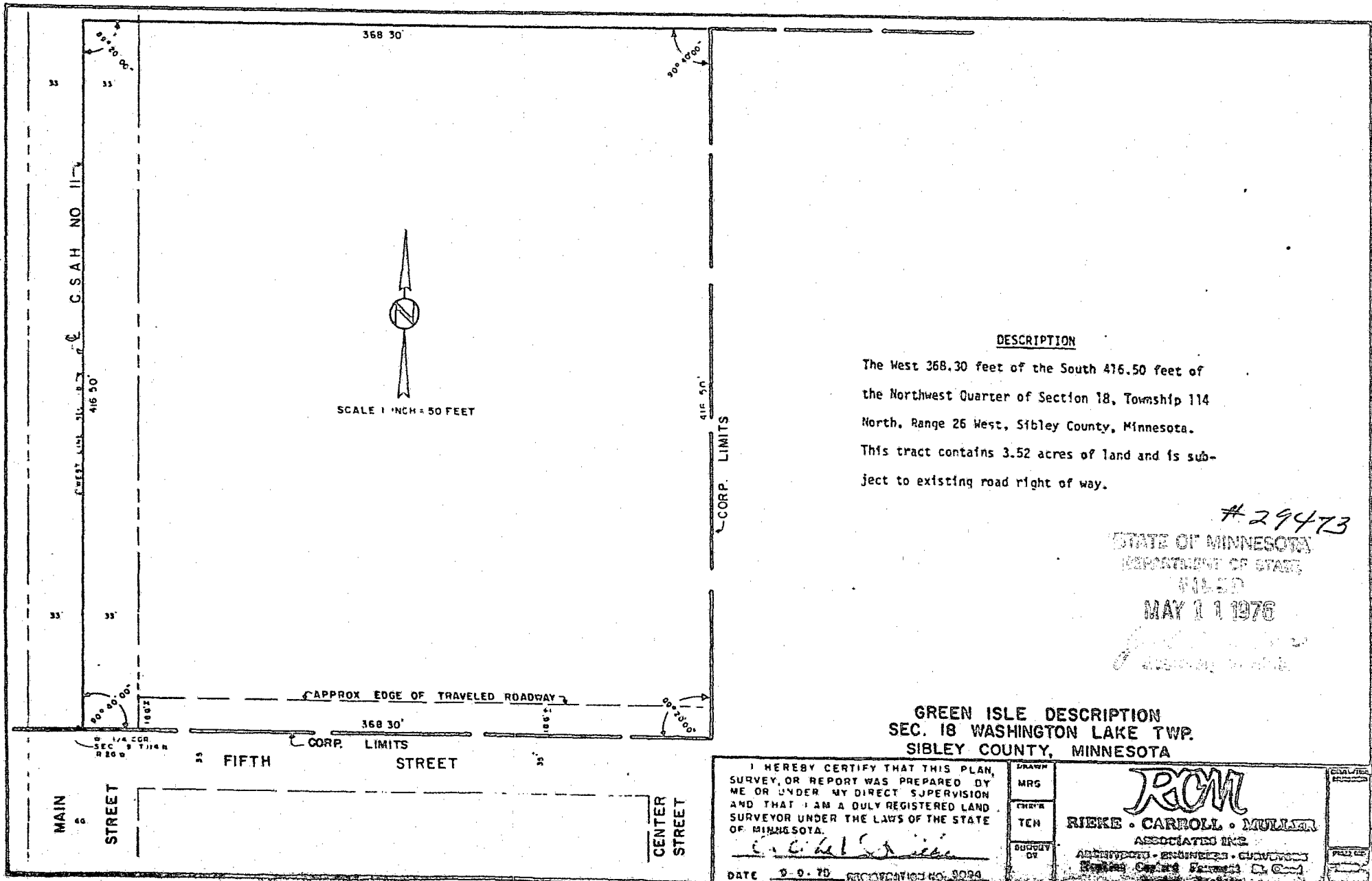
