ORDINANCE NO. 4.07

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF FOSTON TO INCLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE VILLAGE LIMITS AND ADJUTING THEREON AND TO INCLUDE LAND OWNED BY THE VILLAGE OF FOSTON AND ADJUTING THE VILLAGE LIMITS OF THE VILLAGE OF FOSTON.

WHEREAS certain territory described as PART 1 below is not presently included within the corporate limits of any incorporated city, village or borough and this territory is completely surrounded on all sides by lands already included within the corporate limits of the Village of Foston and is deemed to be urban in character; and

WHEREAS, the territory described as PART 2 below is owned by the Village of Foston and abutts the Village of Foston and is deemed to be urban in character and pursuant to Minnesota Statute 414.03;

The Village Council of the Village of Foston ordains:

Section 1. TERRITORY ADDED.

The corporate limits of the Village of Foston, Minnesota, are hereby extended to include the unplatted territory described as PART 1 below, which territory now is and has heretofore been completely surrounded by territory already included within the Village limits and the territory described below as PART 2 which is property owned by the Village of Foston and adjacent to the Village limits of the Village of Foston:

PART 1

Commencing at the Southeast corner of Lot 5, Berge's Addition to the Village of Foston, thence Northeasterly along the Westerly lines of Lots 5 and 6 of Berge's Addition to the Village of Foston to a point due East of the Southeast corner of Lot 4, Berge's Addition to the Village of Foston, thence due west to the East line of North Park Avenue in the Village of Foston, thence Southwesterly to the Northwesterly corner of Block 10, Stephen's Addition to the Village of Foston, thence due East to the point of beginning; and

Commencing at the Southeast corner of Lot 17, Berge's Addition to the Village of Foston, thence due South to the North line of Block 2, Lakeside Addition to the Village of Foston, thence due West along the North line of Block 2, Lakeside Addition a distance of 100 feet,

thence due north to the southwest corner of lot 17, Barge's addition to the Village of Fosston, thence due east on the south line of said lot 17 to the point of beginning.

PAGE 2

That part of the Northwest Quarter of the Northwest Quarter of Section 10, and that part of the Southwest Quarter of the Southwest Quarter of Section 3, all in Township 147 North of Range 40 West described as follows, to-wit: Beginning at the northwest corner of Section 10, Township 147 North of Range 40 West, thence due north along the west line of said section 3, Township 147 North of Range 40 West a distance of 46.4 feet to the Great Northern Railway Company right of way, thence south $55^{\circ}10'$ east along the said railroad right of way for a distance of 284.15 feet; thence south and parallel with the west line of Section 10, Township 147 North of Range 40 West a distance of 268.54 feet; thence west at right angles for a distance of 253 feet to the west line of said Section 10; thence north along the west line of said section 10 for a distance of 384.56 feet to the point of beginning, and a tract of land located in the Northeast Quarter (NE^{1/4}) of Section Four (4), Township One Hundred Forty-seven (147) North, Range Forty (40) West of the Fifth Principal Meridian, described by notes and bounds as follows: Commencing at the point of intersection between the northerly boundary line of Vig's Addition to the Village of Fosston and the westerly boundary line of Granum Avenue; thence westerly along the northerly boundary line of said Vig's Addition for a distance of 497.5 feet; thence at right angles in a northerly direction and parallel with Granum Avenue for a distance of 211.7 feet; thence at right angles in a westerly direction and parallel with the northerly line of Vig's Addition for a distance of 500 feet; thence at right angles in a northerly direction and parallel with Granum Avenue for a distance of 775 feet; thence at right angles in an easterly direction and parallel with the northerly boundary line of Vig's Addition for a distance of 500 feet; thence at right angles in a southerly direction and parallel

with the westerly boundary line of said Grand avenue for a distance of 725 feet; thence in an easterly direction for a distance of 497.5 feet to a point on the westerly boundary of said Grand Avenue; thence in a southerly direction along the westerly boundary of said Grand Avenue for a distance of 258.8 feet to the point of beginning, said tract consisting of two rectangles approximately cornering one another with a total acreage of 11.9 acres all lying within the boundaries of the Northeast Quarter (NE¹/₄) of Section Four (4), Township One Hundred Forty-seven (147) North, Range Forty (40) West of the fifth Principal Meridian in Polk County, Minnesota.

Section 2 FILING.

The Village Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of Polk County and the Minnesota Municipal Commission.

Section 3. EFFECTIVE DATE OF ANNEXATION.

This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2 hereof.

Adopted by the Village Council of Preston, Minnesota, on June 16, 1969.
