ORDINANCE NO. 442

AN ORDINANCE ANNEXING CERTAIN LAND TO THE CITY OF WASECA, MINNESOTA, AND ESTABLISHING THE ZONING THEREOF.

WHEREAS, the land hereinafter described is unplatted land of less than 200 acres situated in St. Mary's Township, Waseca County, Minnesota, which abuts upon the corporate boundary of the City of Waseca and is hereby deemed to be urban in character within the meaning of Minnesota Statutes Annotated Section 414.033, Subd. 5, and

WHEREAS on October 28, 1975, all of the owners of said land have petitioned to the Council of the City of Waseca to have the land hereinafter described annexed to and included within the corporate limits of the City of Waseca; and

WHEREAS a notice of intent to annex the hereinafter described land has been served upon the Town Board of St. Mary's Township, and 60 days have passed without said Town Board submitting written objections to the annexation to the Commission, and said Township Board has waived any objection to said annexation or public hearings for same and that no objections thereto have been forthcoming, and

WHEREAS, the Council of the City of Waseca has determined that the annexation of said land will be to the best interest of the city and of the territory affected.

NOW THEREFORE BE IT RESOLVED that, pursuant to the provisions of Minnesota Statutes Annotated Section 414.033:

THE CITY OF WASECA DOES ORDAIN:

Section 1. That there is hereby annexed to and included within the corporate limits of the City of Waseca, the following described land in the County of Waseca and State of Minnesota, to-wit:

Including abutting roadways,

Beginning at a point on the South line of the Southwest one-quarter of Section Twelve (12), Township One Hundred Seven (107) North, Range Twenty-three (23) West; said point being 704.3 feet West of the Southeast Corner of said Southwest One-

Quarter of Section Twelve (12), thence continuing West along the South line of the Southwest One-Quarter of Section Twelve (12), a distance of 706.47 feet; thence North parallel to the East line of said Section Twelve (12) to the South line of the Chicago and Northwestern Railway right-ofway; thence Southeasterly along the South line of the Chicago and Northwestern Railway right-ofway to a point North 0° 16' West of the point of beginning; thence South parallel to the East line of said Section Twelve (12) to the point of beginning.

Section 2. All of the land described in Section 1 hereof shall be zoned Industrial District within the meaning of the Zoning Ordinance of the City of Waseca, Minnesota.

Section 3. That a copy of this ordinance shall be filed with the Minnesota Municipal Commission, the Clerk of the St. Mary's Township Board, the Auditor and Register of Deeds of the County of Waseca, Minnesota, and the Secretary of the State of Minnesota.

Section 4. This Ordinance shall take effect 10 days after its legal publication.
