An Ordinance Extending the Corporate Limits of the City of Willmer, a Municipal Corporation of the State of Minnesets, to Include Certain Land Completely Surrounded by Land within the Municipal Limits.

WHEREAS, The hereinafter described property is completely surrounded by land within the City of Willmar, and

WHEREAS, pursuant to the provisions of Minnesota Law, Section 414.033 subd. 4, said land may be annexed by ordinance, and

WHEREAS, The said property to be annexed consists of approximately 43.7 acres, more or less, described as follows, to-wit:

Beginning at the SE corner of the NW¼ of Section 16, T119N, R35W; thence N. along the E. ling of the NW¼ to a point on the S. R/W of T.H. No.

of the NW 44 to a point on the S. R. W of T.H. No. 12; thence NW 1y along the said S. R./W line of T.H. No. 12 a distance of 531.5'; thence S. a distance of 198.5'; thence W. to a point on the W. line of the SE44 of the NW44 of Sec. 16; thence S. along said W. line to a point 278.43' S. of the SW corner of the SE44 of the NW14 thence E. to a point on the E. line of the SW14 of Sec. 16; thence N. 278.43' to the point of beginning.

NOW THEREFORE, The City Council of the City of Willmar hereby determines, ordains and declares as follows:

Section 1. Best Interest of the City of Willmar and area to be Annexed. That the annexation will be to the best interest of the City of Willmar, Minnesota, and of the area to be annexed.

Section 2. Lies Within the City Limits. That the property above described is completely surrounded by the City Limits of the City of Willmar and is so conditioned as property to be subject to City government.

as property to be subject to City government. Section 3. Annexation. The said property is hereby annexed to and included within the City of Willmar, Minnesota, as effectually as if it had originally been a part thereof.

Section 4. Zoning. The area above described shall be zoned I-1, Industrial Park District.

Section 5: Effective Date. This ordinance shall be filed with the Municipal Commission of the State of Minnesota and shall take effect and be of full force and effect from and after the filing a copy of said ordinance with the Municipal Commission of the State of Minnesota, the Town Clork of Willmar Township, County Auditor of Kandiyohi County, Minnesota and the Secretary of State of the State of Minnesota, and from and after its passage and publication.
