WHEREAS, the Honorable William T. Johnson, having made application to the said undersigned Governor Wendell R. Anderson, in a letter dated April 30, 1976, for retirement and extension of his present term up to and including September 1, 1977, and

WHEREAS, the said Judge William T. Johnson will have served continuously as such judge and as such judge of a court of record for a period of fifteen (15) years on that date, and

WHEREAS, M.S. 490.101, Subdivision 4, requires the Governor to make a written order accepting such retirement and extending such term of office, and

WHEREAS, the necessary legal requirements have or will have been met for such retirement and extension of term at the close of business on September 1, 1977,

NOW, THEREFORE, I, Wendell R. Anderson, Governor of the State of Minnesota, acting pursuant to the aforementioned statutes, do hereby order that the present term of office for the said Honorable William T. Johnson be, and it hereby is, extended to and including September 1, 1977, and further order that retirement benefits commence as provided by law at the close of business on the day of September 1, 1977.

Dear Governor Anderson:

Pursuant to Subdivision 4 of Section 4<sup>90</sup>.101 of the Minnesota Statutes, I am herewith applying for an extension of my term of office as a District Judge for the Tenth Judicial District of Minnesota for a period of eight months, that is, until September 1st, 1977.

My term of office expires December 31st, 1976, at which time I will have served 14 years and 4 months. I would like this extension in order to qualify me for 15 years of service so that I may retire at half pay on September 1st, 1977, at which time I would then retire.
