ORDINANCE NO. 100

AN ORDINANCE READING THE CORPORATE LIMITS OF THE CITY OF IVANHOE  
TO INCLUDE CERTAIN UNINCORPORATED UNPLACED LAND NOT APPROPRIATE AND AGREED  
IN AREA ADJACENT UPON THE CITY LIMITS.

WHEREAS, A petition was filed January 10, 1973, requesting  
annexation of the territory hereinafter described was duly presented to  
the council on the 4th day of February, 1973; and

WHEREAS, The community of land enclosed within the area described in  
the petition and bounded on the west by the limits of unincorporated land, no  
part of which is included within the limits of an incorporated city,  
village, or borough; and

WHEREAS, the petition was signed by the sole owner of the territory  
described below, and

WHEREAS, no objections to the annexation have been received from the  
town board, the county board, or the governing body of any municipality  
whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city  
limits at the east boundary thereof;

The council of the City of Ivanhoe, Minnesota ordains:

Section 1. The City council hereby determines (1) that the annexation  
will be to the best interests of the city and of the territory affected  
(2) that the territory described herein abuts upon the city limits and is  
urban or suburban in character; and (3) that none of said territory is  
now included within the limits of any city, village, or borough.

Section 2. Territory Annexed. The corporate limits of the city are  
hereby extended to include the unplaced land described as follows and  
the same is hereby annexed to and included within the city as effectually  
as if it had originally been a part thereof:

That part of the West Half of the Northwest Quarter of Section 2,  
Township 111 North, Range 45 West, Lincoln County, Minnesota, more  
particularly described as follows:

Commencing at the northwest corner of said West Half of the Northwest  
Quarter of Section 2; thence South, assumed bearing, along  
the west line of said West Half of the Northwest Quarter of Section  
2 a distance of 750.00 feet to the point of beginning; thence  
continuing on said bearing of South along said west line of the  
West Half of the Northwest Quarter of Section 2 a distance of  
300.00 feet; thence North 89 degrees 40 minutes 00 seconds East  
along a line parallel to the West line of said West Half of the

Northwest Quarter of Section 2 a distance of 470.00 feet; thence North along a line parallel to said west line of the West Half of the Northwest Quarter of Section 2 a distance of 460.00 feet; thence South 89 degrees 40 minutes 00 seconds West along a line parallel to said north line of the West Half of the Northwest Quarter of Section 2 a distance of 240.00 feet; thence South along a line parallel to said West line of the West Half of the Northwest Quarter of Section 2 a distance of 100.00 feet; thence South 89 degrees 40 minutes 00 seconds West along a line parallel to said north line of the West Half of the Northwest Quarter of Section 2 a distance of 230.00 feet to the point of beginning.

Section 3. Filing. The City clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, the County Auditor and the Town Clerk of Ash Lake Township.

Section 4. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
