RESOLUTION NO. 76-22

A Resolution Adopting An Ordinance Extending The
Corporate Limits Of The City of Grand Rapids
To Include E $\frac{1}{2}$ of the NE $\frac{1}{4}$ of the NE $\frac{1}{4}$, Section 32-55-25.

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city, village or borough, and

WHEREAS, this territory abuts upon the corporate limits of the City of Grand Rapids, and

WHEREAS, this territory has petitioned 100% for annexation to the City of Grand Rapids, and

WHEREAS, Grand Rapids Township, Itasca County, and the Minnesota Municipal Commission did not object to this annexation.

NOW THEREFORE, BE IT RESOLVED, That the City Council of Grand Rapids hereby ordains:

Section 1. Territory Annexed. The corporate limits of the City of Grand Rapids are hereby extended to include the E $\frac{1}{2}$ of the NE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 32, Township 55, Range 25.

Section 2. Filing. The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property is located, and the Minnesota Municipal Commission.

Section 3. Effective Date of Annexation. This ordinance takes effect upon its passage, publication and the filing of certified copies as directed in Section 2.
