



ORDINANCE # 303

AN ORDINANCE ANNEXING UNPLATTED LAND LOCATED IN SECTION 23
AND SECTION 24, TOWNSHIP 36 NORTH, RANGE 31 WEST, BENTON COUNTY
MINNESOTA, TO THE CITY OF SAUK RAPIDS, MINNESOTA

WHEREAS, the City of Sauk Rapids is desirous of annexing the following
legally described property, to-wit:

TRACT "A"

The Northeast Quarter of the Northwest Quarter (NE $\frac{1}{4}$ NW $\frac{1}{4}$) of Section Twenty-
three (23), Township Thirty-six (36) North, Range Thirty-one (31) West, Benton
County, Minnesota, said tract containing 40 acres, more or less.

TRACT "B"

The North Half of the Northwest Quarter of the Northwest Quarter (N $\frac{1}{2}$ NW $\frac{1}{4}$ NW $\frac{1}{4}$)
of Section Twenty-four (24), Township Thirty-six (36) North, Range Thirty-one
(31) West, Benton County, Minnesota, lying westerly of the southwesterly right-
of-way line of S.T.H. # 10 also the Northeast Quarter of the Northeast Quarter
of the Northeast Quarter (NE $\frac{1}{4}$ NE $\frac{1}{4}$ NE $\frac{1}{4}$) of Section Twenty-three (23), Township
Thirty-six (36) North, Range Thirty-one (31) West, Benton County, Minnesota
also the South Half of the Northeast Quarter of the Northeast Quarter (S $\frac{1}{2}$
NE $\frac{1}{2}$ NE $\frac{1}{2}$) of Section Twenty-three (23), Township Thirty-six (36) North, Range
Thirty-one (31) West, Benton County, Minnesota, except the West 522.10 feet
thereof also the Southeast Quarter of the Northeast Quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$) of Section
Twenty-three (23), Township Thirty-six (36) North, Range Thirty-one (31) West,
said Tract "B" containing 66 acres, more or less; and

WHEREAS, all of said property is unincorporated land abutting on the
City of Sauk Rapids, is not included in any other municipality, and does not
border any other municipality; and

WHEREAS, said land is unplatted land and not over 200 acres in area,
and is urban in character; and

WHEREAS, the annexation of said land to the City of Sauk Rapids, Minnesota,
will be to the benefit of the municipality and to the territory herein described;
and

WHEREAS, the Notice of Intent to Annex was served upon the Sauk Rapids
Township Board by mail, on February 20, 1976; and


WHEREAS, no written objections to the annexation have been filed with the Minnesota Municipal Commission; and

WHEREAS, the Sauk Rapids City Council hereby ordains as follows:


1. That the above described property shall be and the same hereby is, annexed to and included in the City of Sauk Rapids, Minnesota, as effectually as if originally made a part hereof.

2. That this ordinance shall take effect from and after its passage and publication as provided by law, and upon filing a copy of this ordinance with the Minnesota Municipal Commission, the Sauk Rapids Township Clerk, the Benton County Auditor and the Minnesota Secretary of State, as required by M.S.A. 414.033.
