

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF STAPLES AND INCORPORATING ADDITIONAL TERRITORY THEREIN.

The City Council of the City of Staples does ordain as follows:

Section 1.

The following described real estate is completely surrounded by land within the City limits of the City of Staples:

Lot 4, Block 1, Park Estates, according to the plat thereof on file and of record in the office of the Register of Deeds in and for Wadena County, Minnesota, together with all abutting roads and streets.

Section 2.

The City Council hereby determines that the annexation would be to the best interest of the City of Staples, Minnesota and of the territory affected; and that the land is urban in character and is so conditioned as properly to be subjected to city government.


Section 3.

Therefore, the City of Staples, Minnesota hereby ordains and declares that the property hereinbefore described be, and the same hereby is, annexed to, and included in, the City of Staples, Minnesota, as effectually as if it had originally been a part thereof.


Section 4.

This Ordinance shall be final and shall take effect and be in force from and after filing a certified copy thereof with the Minnesota Municipal Commission, the town clerk of Thomastown Township, the Wadena County Auditor, and the Minnesota Secretary of State.


