

Ordinance 76-7

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF FARIBAULT TO INCLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated City or borough; and

WHEREAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of the City and is deemed to be urban in character;

THE CITY OF FARIBAULT ORDAINS:

Section 1. TERRITORY ANNEXED. The corporate limits of the City of Faribault, Minnesota, are hereby extended to include the unplatted territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the City limits:

The east two hundred fifty nine (259) feet of the north four hundred ninety eight (498) feet of the north one-half (N1/2) of the Southeast Quarter (SE1/4) of Section One (1), Township one hundred nine (109) North of Range twenty-one (21) West in the County of Rice and State of Minnesota.

and

All that part of the South one-half (S1/2) of the Southeast Quarter (SE1/4) of Section one (1), Townships one hundred nine (109) North, Range Twenty-one (21) West in the County of Rice and State of Minnesota, lying South of the right-of-way of the Chicago, Milwaukee and St. Paul Railway Company described as beginning at a point in the East line of said South half (S1/2) of the Southeast Quarter (SE1/4) of Section one (1), 302 feet northerly of the Southeast Corner of said Section 1, thence westerly at right angles to the said east line 213 feet; thence northerly parallel to the east line ninety (90) feet; thence westerly at right angles 213 feet; thence northerly at right angles 137 feet; thence easterly at right angles 213 feet; thence northerly at right angles 128.6 feet; thence easterly at right angles 213 feet to said east line; thence southerly 355.6 feet to the point of beginning.

Section 2. FILING. The City Administrator is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of Rice County, the Town Clerk of Warsaw Township and the Minnesota Municipal Commission.
