OPDIMANCE NUMBER 1975-1

AN ORDITANCE ENTENDING THE CORPORATE LIMITS OF THE CITY OF ALDANY, STEARNS COUNTY, MINHESOTA TO IN-CLUSE CERTAIN UNINCORPORATED UNPLAYING LAND NOT FX-CREDING 200 ACRES IN AREA AND ABUTTING UPON-THE TRESENT CITY LIMITS

WHEREAS: the quantity of land embraced within the area described in the petition and bounded as described is ten (10) acres (more or less) of unplatted land, no part of which is included within the limits of an incorporated city; and

WIEREAS: the potition for ameration was signed by all of the owners; and

WIMBAS: no objections to the annexation have been received from the town board, the county beard or other governing body or any municipality whoes abut upon the boundaries of the land to be ennexed: and

WHEREAS: the land described in the petition abuts upon the city limits on its vesterly boundaries thereof; The City Council of the City of Albany, Steams County, Minnesota ordains:

Section 1. The city council hereby determines (1) that the annexation will be to the best interests of the city and the territory affected; (2) that the territory herein described abuts upon the city limits and is about to become urban or suburban in character; and (3) that none of the said territory is now included within the limits of any city.

Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the unplatted described as follows and the same is hereby ennexed to and included within the city as effectively as if it had been originally part thereof:

19.00 A SV $_{*}^{1}$ SE $_{*}^{1}$ N of Ry. less E 237' Sec 16 T 125 E 31 and less the V 330'.

Section 3. Filing. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor.

Section 4. Effective Date. This ordinance take effect upon its passage and publication and the filing of the certified copies as directed in Section 3.


