AN ORDINANCE ANNEXING LAND

The Village Council of Watson ordains:

A Petition for the annexation of the hereinafter described land to the Village of Watson, signed by all the owners thereof, having been duly filed with the Village and copies thereof having been filed with the Municipal Commission of the State of Minnesota, the Town Board of Tunsberg Township and the County Board of Chippewa County, and the Town Board of Tunsberg Township having waived the time for objecting to the Petition and having consented to the annexation of the land to the Village of Watson, it is hereby determined by the Village Council of the Village of Watson that the hereinafter described land is urban or suburban in character and is susceptible to the municipal control and government of the Village of Watson and that the annexation of said land to the Village of Watson will be to the best interests of the Village and of the territory affected thereby; and said land located in the County of Chippewa and State of Minnesota described as follows:

That part of the Northwest quarter (NW $\frac{1}{4}$) of the Southwest quarter (SW $\frac{1}{4}$) of Section Twenty-two (22), Township One Hundred Eighteen (118) North, Range Forty-one (41) West, beginning at the Northwest corner of said Northwest quarter (NW $\frac{1}{4}$) of said Southwest quarter (SW $\frac{1}{4}$), thence east along the north line of said Northwest quarter (NW $\frac{1}{4}$) of said Southwest quarter (SW $\frac{1}{4}$) to the state trunk highway right-of-way, thence southerly along said right-of-way to a point directly east of a point on the west line of said Northwest quarter (NW $\frac{1}{4}$) of said Southwest quarter (SW $\frac{1}{4}$) which is Six Hundred Ninety-seven feet (697') south of the point of beginning, thence west to said point on the west line of said Northwest quarter (NW $\frac{1}{4}$) of said Southwest quarter (SW $\frac{1}{4}$), and thence north Six Hundred Ninety-seven feet (697') to the point of beginning containing 1 acre, more or less, and

That part of the Northeast quarter (NE $\frac{1}{4}$) of the Southeast quarter (SE $\frac{1}{4}$) of Section Twenty-one (21), Township One Hundred Eighteen (118) North, Range Forty-one (41) West, beginning at the Northeast corner of said Northeast quarter (NE $\frac{1}{4}$) of said Southeast quarter (SE $\frac{1}{4}$), thence west along the north line of said Northeast quarter (NE $\frac{1}{4}$) of said Southeast quarter (SE $\frac{1}{4}$) for a distance of Three

Hundred Forty-eight feet (348'), thence south for a distance of Three Hundred Sixty-five feet (365'), thence east for a distance of Three Hundred Forty-eight feet (348') to the east line of said North-east quarter (NE $\frac{1}{4}$) of said Southeast quarter (SE $\frac{1}{4}$) and thence north Three Hundred Sixty-five feet (365') along said east line to the point of beginning containing 2.92 acres, more or less,

is hereby annexed to, made a part of, and is included within the territorial boundaries of the Village of Watson as provided by Minnesota Statutes 414.033, Subdivision 5.

This Ordinance shall become effective twenty (20) days after its passage and publication upon filing copies thereof with the Municipal Commission of the State of Minnesota, the Town Clerk of Tunsberg Township, the County Auditor of Chippewa County and the Secretary of State of the State of Minnesota.
