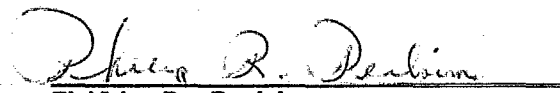

ORDINANCE NO. 146

AN ORDINANCE PROVIDING FOR ANNEXATION OF CERTAIN LAND ABUTTING THE CITY OF DELANO, MINNESOTA, UPON PETITION OF ALL OF THE OWNERS OF SUCH LAND.

THE CITY COUNCIL OF DELANO, MINNESOTA, ORDAINS:

Section 1. That pursuant to a petition by all of the owners of certain property comprising less than two hundred (200) acres, heretofore described as follows:

A tract of land described as follows: Beginning at the Northeast corner of the Northwest quarter of Section 14, Township 118, Range 25, running thence West 24 rods, thence South 80 rods, thence East 21 rods, thence North 80 rods to place of beginning.

the city council has unanimously determined that it is to the best interest of the city and to the best interest of the property to be annexed that it be annexed.

Section 2. The tract hereinbefore described is, by this Ordinance, declared to be annexed to the City of Delano, Minnesota.

Section 3. This Ordinance shall take effect upon its passage and publication, and upon the filing of a copy of this Ordinance with the Municipal Commission of the State of Minnesota, the County Auditor of Wright County, and the Secretary of State of the State of Minnesota.
