Dear Judge Fosseen:

It is our understanding of Minnesota Statutes, Section 490.121, Subd. 12 and 490.125, based on consultations with the Attorney General's Office, that retirement of a judge is mandatory the last day of the month in which age 70 is attained. The only exceptions to this is as provided in 490.124, Subd. 2, which allows an extension if the judge needs the extension to qualify for full benefits under the "old" law provisions or as provided in 490.125, Subd. 2, an extension to the end of the term for those judges who were 70 or older on December 31, 1973.

As your 70th birthday is June 10th, we have calculated an estimate of the amount of your retirement benefit. Based on a retirement date of June 30, 1976, your average monthly salary for the highest 5 years in the last 10 is \$2,633.70. Twenty-nine years of service provides a percentage factor of 72.5% to be applied to the high 5 year average salary. However, the law limits the benefit payment to a maximum of 60% of annual salary for the year preceding retirement.

Sixty percent of your current annual salary of \$33,740 provides an annuity of \$20,100.00 per year, or \$1,675.00 per month.

You did elect to continue contributions to the special survivors benefit account to provide payment of one-half of your retirement annuity to your spouse after

Increases in your benefit after retirement or in your spouse's benefit will be made in the same manner and at the same time as retired State employees.

Minnesota Statutes, Section 490.124, Subd. 7, states that no retired judge shall receive a retirement annuity while practicing law in Minnesota.

Enclosed is an application form for the annuity. Sign it in the presence of a Notary Public, have the Notary sign and affix his seal and then return the application to this office.

While application for the annuity is made to this office on the enclosed form, Section 490.126 provides that written application for retirement must be made to the Governor.
